11 **ADOPTING THE CITY OF SANTA FE'S FISCAL YEAR 2022/2023 OPERATING BUDGET**  
12 **AND ORGANIZATIONAL CHART.**

15 annual budget and proposed spending priorities for review and approval by the Finance Committee for  
16 the municipality of the City of Santa Fe, State of New Mexico; and

17 **WHEREAS**, the Finance Committee recommended approval of the Mayor's proposed budget  
18 and organizational chart for fiscal year 2022/2023, attached to this Resolution; and

19 **WHEREAS**, the recommended budget was brought forth in the spirit of positive collaboration  
20 among departmental staff and elected officials; and

21 **WHEREAS**, the meetings of the City's Finance Committee for the review of said budget were  
22 duly advertised in compliance with the New Mexico Open Meetings Act; and

23 **WHEREAS**, the proposed budget addresses the needs and goals of the City as currently  
24 determined for fiscal year 2022/2023.

5 the organizational chart included in the fiscal year 2022/2023 budget.




