**A RESOLUTION**

**REQUESTING A TERM EXTENSION FOR A LOCAL GOVERNMENT ROAD FUND COOPERATIVE AGREEMENT FROM THE NEW MEXICO DEPARTMENT OF TRANSPORTATION, IDENTIFIED AS CONTROL NUMBER L500306, FOR THE PLANNING, DESIGN, AND CONSTRUCTION OF AGUA FRIA STREET AND SOUTH MEADOWS ROAD INTERSECTION IMPROVEMENTS.**

**WHEREAS**, on October 22, 2018 the City of Santa Fe ("City") and the New Mexico Department of Transportation ("NMDOT") entered into a Local Government Road Fund Cooperative Agreement ("Agreement"), Contract No. D17045 for \$440,750.00 to plan, design, construct intersection improvements at Agua Fria-South Meadows identified as Control No. L500306; and

**WHEREAS**, the City local match is \$146,917; and

**WHEREAS**, the total project funding is \$587,667; and

**WHEREAS**, the original termination date of the Agreement was June 30, 2020; and

**WHEREAS**, the term of the Agreement has been extended twice; and

1           **WHEREAS**, the first amendment for term extension to December 31, 2021 was approved  
2 by the Governing Body with Resolution 2020-4; and


3           **WHEREAS**, the second amendment for term extension to December 31, 2022 was  
4 approved by the Governing Body with Resolution 2021-74; and

5           **WHEREAS**, the City requires an additional term extension to December 31, 2023, due to  
6 delays in acquiring rights-of-way.

7           **NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE**  
8 **CITY OF SANTA FE** that the Governing Body requests a 12-month time extension of the  
9 Agreement from NMDOT to December 31, 2023.

10           **BE IT FURTHER RESOLVED** that the City accepts responsibility for the Project;  
11 assumes the lead role in design development and construction of the Project; agrees to the terms,  
12 conditions, and certification and reporting requirements of the Local Government Road Fund  
13 Cooperative Agreement; and assumes ownership, liability, and maintenance responsibilities for all  
14 amenities related to the completion of the Project.

15           PASSED, APPROVED, and ADOPTED this 12<sup>th</sup> day of October, 2022.


