10 **A RESOLUTION**

11 **APPROVING THE CITY OF SANTA FE’S PARTICIPATION IN A TRANSPORTATION**  
12 **PROJECT FUND PROGRAM ADMINISTERED BY NEW MEXICO DEPARTMENT OF**  
13 **TRANSPORTATION FOR THE ARROYO DE LOS CHAMISOS CROSSING PROJECT.**

14  
15 **WHEREAS**, the City of Santa Fe (“City”) and the New Mexico Department of  
16 Transportation (“NMDOT”) wish to enter into the attached grant agreement (Exhibit A) pursuant  
17 to the Transportation Project Fund Program (“TFP”) for the Arroyo de los Chamisos Crossing  
18 Project; and

19 **WHEREAS**, under the terms of the agreement, the total cost of the project is anticipated  
20 to be \$1,000,000 and will be funded in proportional share by the parties hereto as follows:

- 21 1. NMDOT’s share is ninety-five percent or \$950,000; and  
22 2. The City’s proportional matching share is five percent or \$50,000; and

23 **WHEREAS**, the agreement provides that the City will pay all costs that exceed the total  
24 budgeted amount of \$1,000,000, to the extent permitted under law.


25 **NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE**

1 **CITY OF SANTA FE** that the cooperative agreement for Project Control Number LP50039 with  
2 the NMDOT for the TPF Program for year 2023 for the Arroyo de los Chamisos Crossing project  
3 extending Richards Avenue north across the Arroyo de Los Chamisos to connect to existing  
4 Richards Ave/Rodeo Rd to the Richards Avenue/Cerrillos Road signalized intersection is hereby  
5 approved. The Scope of Work includes traffic calming measures, bicycle lanes, sidewalks, and  
6 storm water drainage improvements within the boundaries of the City.

7 **BE IT FURTHER RESOLVED** that the City maintains this project as a priority.


8 **BE IT FURTHER RESOLVED** that the cooperative agreement expires on June 30,
