11	APPROVING A PUBLIC FIREWORK DISPLAY DURING THE SANTA FE PLAZA
12	2023-2024 NEW YEAR'S EVE EVENT.

14	WHEREAS, Resolution 2016-24 directed that City of Santa Fe staff "plan and execute"
15	New Year's Eve annually as part of the "People to the Plaza" initiative; and
16	WHEREAS, New Years Eve is held within City limits and utilizes fireworks to celebrate
17	and
18	WHEREAS, Section 12-3.3, "Public Display" states that permits for the public display or
19	fireworks "shall be granted on application to the fire department, approval by the governing body
20	and the filing of a bond by the applicant"; and
21	WHEREAS, the City has engaged Western Enterprises, Inc., and Kiwanis Club to act or
22	the City's behalf to plan and execute the event; and
23	WHEREAS, Western Enterprises, Inc./Kiwanis Club of Santa Fe, submitted, on behalf or
24	the City, a complete application to the Fire Department to hold a New Year's Eve event on the
25	Plaza on December 31, 2023, requesting that the City have permission to stage fireworks at the La

1	Fonda Hotel, which is within the City limits; and
2	WHEREAS, the City's Fire Marshal determined in his professional capacity that the
3	planning for the New Year's event, as described by the City's application, demonstrates the
4	applicant has taken appropriate safety measures; and
5	WHEREAS, the Governing Body supports the use of fireworks during an annual City
6	event on New Year's Eve, so long as the use complies with SFCC 1987, Section 12-3, "Fireworks",
7	including the stipulations outlined in section 12-3.9, "Restrictions during severe or extreme drought
8	conditions".
9	NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE
10	CITY OF SANTA FE that the Governing Body approves the set up for and use of fireworks on
11	New Year's Eve, December 31, 2023, and on New Year's Day, January 1, 2024, to be staged at La
12	Fonda Hotel.
