A RESOLUTION

**AUTHORIZING THE SALE AND CONSUMPTION OF BEER AND HARD CIDER
DURING THE PARTY ON THE PITCH SOCCER TOURNAMENT ON JUNE 1-2, 2024,
PURSUANT SUBSECTION 23-6.2(C) SFCC 1987.**

WHEREAS, SFCC 1987, Section 23-6.2 governs the consumption of alcohol on city property; and

WHEREAS, for locations not specifically mentioned in SFCC 1987, Section 23-6.2(A), the ordinance requires the Governing Body to approve a resolution that specifies the event, date, hours, location, number of expected attendees, type of alcohol to be served, permits, and insurance, at least thirty days prior to the event; and

WHEREAS, the Santa Fe Adult Soccer League (“SFASL”) held a “Party on the Pitch: tournament at the Metropolitan Recreation Center (“MRC”)” (“Party on the Pitch”) in 2019, 2022, and 2023, and held it previously at other locations; and

WHEREAS, SFASL plans to support local business by partnering with New Mexico Hard Cider to provide beverages for players and fans to enjoy during and after games held over the two-

1 day Party on the Pitch; and

2 **WHEREAS**, SFASL hopes to attract increasing numbers of out-of-city and out-of-state
3 teams to the Party on the Pitch, capitalizing on the ongoing improvements at the MRC.

4 **NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE**
5 **CITY OF SANTA FE** that alcohol service during the Party on the Pitch soccer tournament is
6 hereby approved according to the following parameters:

- 7 Event: Party on the Pitch Soccer Tournament
- 8 Dates: June 1-2, 2024
- 9 Hours: 10:00 a.m. to 10:00 p.m. on Saturday, June 1, 2024, and
10 12:00 p.m. (noon) to 5:00 p.m. on Sunday, June 2, 2024
- 11 Location: Municipal Recreation Complex soccer fields
- 12 Number of expected attendees: No more than 100 at a time in the beer garden.
- 13 Type of alcohol to be served: Beer and hard cider
- 14 Required Permits: Special dispenser permit
- 15 Required insurance: Liquor Liability insurance in the amount of
16 \$1,050,000.00.
