19	specifies the event, date, hours, location, number of expected attendees, type of alcohol to be		
20	served, permits, and insurance, at least thirty (30) days prior to the event; and		
21	WHEREAS, the Santa Fe Century ("Century") is an annual bicycle event that has been		
22	held since 1985; and		
23	WHEREAS, according to the Century's website, approximately two thousand (2,000)		
24	cyclists participate in the Century's events every year; and		
25	WHEREAS, the Century consists of a variety of cycling events for differing abilities that

18		directors, employees, and agents as additional insureds on	
19		a primary and noncontributory basis. The Santa Fe
