11	ESTABLISHING A PLAN FOR USE OF BUDGETED FUNDS TO STUDY HIRING
12	COUNCIL STAFF.
13	WHEREAS, the City of Santa Fe (City) Fiscal Year 2025 Budget included funding in its
14	General Government budget that the City's budget book, page 63, described as "a study to make
15	recommendations on staff support for City Councilors"; and
16	WHEREAS, the General Government budget also includes funding for personnel that can
17	be used to hire staff to support City Councilors; and
18	WHEREAS, the City's Governing Body would like to utilize no more than \$60,000 of
19	these funds for the following work, to be completed by a Contactor within 60 days of the initiation
20	of the Contract or as soon as is possible:
21	a. Interview City Councilors to elicit their staffing needs and interests;
22	b. Explore staffing models of other City Councils to inform City Councilors on
23	potential models;
24	c. Summarize the staffing model for Santa Fe County Commissioners and the
25	new policy positions being implemented for State Legislators including

1	salaries and relevant job descriptions;
2	d. Provide a proposed staffing model that reflects the needs and interests of City
3	Councilors, including a budget and position descriptions vetted with the
4	Human Resources Department to confirm that the descriptions conform to City
5	standards; and
6	e. Compile the above information in a report to be presented to the Governing
7	Body in a study session.
8	NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE
9	CITY OF SANTA FE that the City Manager shall direct procurement of an appropriate contractor
10	to conduct the scope of work described above.
11	BE IT FURTHER RESOLVED that, once the contractor has completed the scope of
12	work outlined in this resolution, the City Manager shall present the report to the Governing Body
13	in a study session.
