**A RESOLUTION**

**AUTHORIZING THE SALE AND CONSUMPTION OF BEER AND WINE DURING  
PORTIONS OF THE INTERNATIONAL FOLK ART MARKET ON JULY 10 AND 12,  
2025, PURSUANT TO SUBSECTION 23-6.2(C) SFCC 1987.**

**WHEREAS**, SFCC 1987, Section 23-6.2, governs the consumption of alcohol on city  
property; and

**WHEREAS**, for serving alcohol at City properties not specifically mentioned in SFCC  
1987, Section 23-6.2(A), the ordinance requires the Governing Body to approve a resolution that  
specifies the event, date, hours, location, number of expected attendees, type of alcohol to be  
served, permits, and insurance, at least thirty (30) days prior to the event; and

**WHEREAS**, the International Folk Art Market (“IFAM”) is an annual event featuring  
artisans from throughout the world; and

**WHEREAS**, IFAM is a significant event benefiting the City of Santa Fe’s tourism  
industry; and

**WHEREAS**, IFAM wishes to partner with Tumbleroot Brewery and Distillery, promoting  
a local business to the community.

**NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF SANTA FE** that alcohol service during IFAM is hereby approved according to the following parameters:

Event: International Folk Art Market events

Dates: July 10 and July 12, 2025

Hours: 6:00 p.m. to 9:00 p.m.

Location: The Railyard Park


Number of expected attendees: Up to 2,500 attendees are expected in the Railyard Park at any given time during the event.

Type of alcohol to be served: Beer and wine.

Required Permits: Public Celebration Permit.

Required Insurance: Liquor Liability insurance with limits not less than \$2,000,000, per occurrence and in the aggregate, with the City of Santa Fe, its officials, directors, and employees, and agents as additional insureds on a primary and noncontributory basis. The International Folk Art Market shall provide the City with Certificates of Insurance and applicable endorsements evidencing such coverage.
