11	RESTRICTING THE WEIGHT LIMIT ON THE CERRO GORDO BRIDGE NO. 8838
12	NOT TO EXCEED A GROSS WEIGHT LIMIT OF FIFTEEN (15) TONS UNTIL REPAIRS
13	ARE MADE; DIRECTING INSTALLATION OF WEIGHT LIMITATION SIGNS IN
14	ADVANCE OF THE BRIDGE AND NOTICE OF THIS RESOLUTION SENT TO THE
15	NEW MEXICO MOTOR TRANSPORTATION DEPARTMENT, AS REQUIRED BY
16	STATE LAW; SPECIFYING THAT VIOLATION OF THE WEIGHT LIMIT IS A
17	MISDEMEANOR, PUNISHABLE BY THE PENALTIES IN NMSA 1978, SECTION 66-8-
18	7; AND DIRECTING NOTICE TO THE NEW MEXICO DEPARTMENT OF
19	TRANSPORTATION WHEN REPAIR COMPLETION AND FULL ACCESS TO THE
20	BRIDGE IS RESTORED.
21	WHEREAS, On April 7, 2025, Rich Rotto, PE structural engineer with AECOM
22	("AECOM Engineer"), evaluated Cerro Gordo Bridge No. 8838, which spans the Santa Fe River
23	and connects Upper Canyon Road with Cerro Gordo Road ("Bridge"); and
24	WHEREAS, the results of the evaluation indicate that the Bridge's load bearing capability
25	is deteriorating and reducing the traffic loading would increase the expected life of the Bridge: and

1	WHEREAS, the results of the structural evaluation led the AECOM Engineer to
2	recommend that the City reduce the permissible vehicle weight loads on the Bridge to fifteen (15)
3	tons; and
4	WHEREAS, the State Bridge Load Rating Engineer reviewed and confirmed the AECOM
5	Engineer's determination in accordance with New Mexico Department of Transportation's load
6	rating procedures; and
7	WHEREAS, alternate routes exist for vehicles with a gross vehicle weight of more than
8	fifteen (15) tons to access both Cerro Gordo Road and Upper Cayon Road; and
9	WHEREAS, pursuant to NMSA 1978, Section 66-7-415, the Governing Body of the City
10	of Santa Fe ("City") may restrict truck traffic upon the City's public streets under certain
11	circumstances when the street is primarily residential, passes by educational or medical facilities,
12	or is not designed or constructed for heavy weight vehicles; and
13	WHEREAS, the Bridge is primarily residential;
14	WHEREAS, consistent with the permitted criteria for limiting weight on public streets in
15	NMSA 1978, 66-7-415, the street is primarily residential;
16	WHEREAS, NMSA 1987, Section 66-7-415, provides that a resolution restricting traffic
17	shall be effective when "signs are erected and maintained and notice given in writing to the nearest
18	officer or employee of the New Mexico state police division of the department of public safety
19	authorized to issue special permits".
20	NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE
21	CITY that vehicles using the Bridge shall not exceed a gross weight limit of fifteen (15) tons until
22	repairs of the bridge are completed.
23	BE IT FURTHER RESOLVED that the City shall complete a design and cost-estimate
24	for the repairs and shall develop a repair plan accordingly.
25	BE IT FURTHER RESOLVED that the City shall forward a copy of this Resolution to

1	the New Mexico Motor Transportation Department, as required by state law.
2	BE IT FURTHER RESOLVED that the City shall install weight limitation signs
3	appropriately and conspicuously in advance of both sides of the Bridge as well as in advance of the
4	Bridge at a location where large vehicles can turn around.
5	BE IT FURTHER RESOLVED that violation of the weight limit imposed by this
6	Resolution shall be a misdemeanor, punishable by the penalties in NMSA 1978, Section 66-8-7.
7	BE IT FURTHER RESOLVED that, once repairs are complete, the City shall notify the
8	New Mexico Department of Transportation that repairs have been completed, remove the weight
9	limitation signs, and restore full access to the Bridge.
