**A RESOLUTION**

**AUTHORIZING THE SALE AND CONSUMPTION OF BEER AND WINE DURING THE  
RAILYARD PLAZA SUMMER SCENE CONCERT SPONSORED BY  
INDIGENOUSWAYS ON AUGUST 15, 2025, PURSUANT TO SUBSECTION 23-6.2(C)  
SFCC 1987.**

**WHEREAS**, SFCC 1987, Section 23-6.2, governs the consumption of alcohol on City  
property; and

**WHEREAS**, for serving alcohol at City properties not specifically mentioned in SFCC  
1987, Section 23-6.2(A), the ordinance requires the Governing Body to approve a resolution that  
specifies the event, date, hours, location, number of expected attendees, type of alcohol to be  
served, permits, and insurance, at least thirty (30) days prior to the event; and

**WHEREAS**, the Railyard Plaza Summer Scene Concert event series has taken place  
annually for sixteen (16) years; and

**WHEREAS**, the Railyard Plaza Summer Scene Concert on August 15, 2025, will be  
sponsored by IndigenousWays; and

**WHEREAS**, IndigenousWays is a Native-led Indigenous Arts nonprofit that highlights

indigenous artists of all media; and

**WHEREAS**, since 2007, IndigenousWays has offered educational programs, including artistic and musical performances, as well as initiatives aimed at promoting cultural awareness, values, and traditions; and

**WHEREAS**, IndigenousWays intends to work with “As Above, So Below”, a local distillery, to serve beer and wine for the event, promoting a local business to the community.

**NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF SANTA FE** that alcohol service during the Railyard Plaza Summer Scene Concert sponsored by IndigenousWays, is hereby approved according to the following parameters:

Event: Railyard Plaza Summer Scene Concert

Sponsored by IndigenousWays

Dates: August 15, 2025

Hours: 6:30 p.m. to 9:30 p.m.

Location: Railyard Plaza

Number of expected attendees: 500 to 1,000

Type of alcohol to be served: Beer and Wine


Required Permits: Public Celebration Permit

Required Insurance: Liquor Liability and General Liability insurance with limits not less than \$2,000,000, per occurrence and in aggregate, with the City of Santa Fe, its officials, directors, employees, and agents as additional insureds on a primary and noncontributory basis. As Above, So Below Distillery shall provide the City with Certificates of Insurance and applicable endorsements
