A RESOLUTION

CLARIFYING THE TERMS OF RESOLUTION NO. 2024-14 TO ALLOW THE KNIGHTS OF COLUMBUS COUNCIL 10517 TO DISPLAY BANNERS COMMEMORATING SANTA FE VETERANS AS “SANTA FE HEROES” BETWEEN MEMORIAL DAY AND VETERANS DAY, ANNUALLY.

WHEREAS, Section 14-7.6(B), Santa Fe City Code (SFCC) 1987 allows for the installation of banners to identify the geographic location associated with local business groups, neighborhoods, or community groups; the dates associated with important civic milestones, activities, or holidays; or a sense of place and community that are erected by the City of Santa Fe (“City”) or its permittee, if approved by the City’s Governing Body via resolution; and

WHEREAS, in Resolution No. 2024-21 the City approved the Knights of Columbus Council 10517 to “display banners every year, between Memorial Day and Veterans Day, with installation of the banners occurring as early as the week before Memorial Day and removal occurring up to the week after Veterans Day”; and

WHEREAS, the caption of Resolution No. 2024-21 stated that the banner display would take place “in 2024 and 2025”, creating inconsistency between the resolution’s caption and the

Attorney’s Office is required to ensure conformance with the City’s code.

Installation: The Knights of Columbus is responsible for the installation of the banners associated with this request, including obtaining the obstruction permits required for installation and removal of the banners pursuant to standard City and State procedures, as applicable.

Maintenance: The Knights of Columbus shall immediately replace banners that become damaged, defaced, or are in any form of disrepair, at the expense of the Knights of Columbus. The City reserves the right to remove any banners the City deems in disrepair prior to their scheduled removal date.


Cost Allocation: The Knights of Columbus shall purchase or otherwise obtain, install, and remove the banners.
