**A RESOLUTION**

**REQUESTING A TERM EXTENSION TO A LOCAL GOVERNMENT ROAD FUND COOPERATIVE AGREEMENT FROM THE NEW MEXICO DEPARTMENT OF TRANSPORTATION IDENTIFIED AS CONTROL NUMBER L500444 FOR THE PLANNING, DESIGN, AND CONSTRUCTION OF AGUA FRIA STREET AND SOUTH MEADOWS ROAD INTERSECTION IMPROVEMENTS.**

**WHEREAS**, on September 23, 2021 the City of Santa Fe ("City") and the New Mexico Department of Transportation ("NMDOT") entered into a Local Government Road Fund ("LGRF") Cooperative Agreement, Contract No. D19006 for \$56,875.00 ("Agreement") to plan, design, construct intersection improvements at Agua Fria-South Meadows identified as Control No. L500444; and

**WHEREAS**, the City local match is \$18,958.00; and

**WHEREAS**, the total project funding is \$73,833.00; and

**WHEREAS**, the original termination date of the Agreement was on December 31, 2022;

and

1           **WHEREAS**, the Agreement states that it may be altered, modified, or amended by an  
2 instrument in writing executed by the parties; and

3           **WHEREAS**, the City desires to modify the Agreement to extend its term.

4           **NOW THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE**  
5 **CITY OF SANTA FE** requests a 12-month time extension of the Agreement to December 31,  
6 2023.

7           **BE IT FURTHER RESOLVED** that the City accepts responsibility for the Project;  
8 assumes the lead role in design development and construction of the Project; agrees to the terms,  
9 conditions, and certification and reporting requirements of the LGRF cooperative agreement; and  
10 assumes ownership, liability, and maintenance responsibilities for all amenities related to the  
11 completion of the Project.
