10 **A RESOLUTION**

11 **AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOL DURING THE**
12 **INTERNATIONAL FOLK ART MARKET ON JULY 6-8, 2023, PURSUANT TO SFCC**
13 **1987, SECTION 23-6.2(C).**

15 **WHEREAS**, SFCC 1978, Section 23-6.2 governs the consumption of alcohol on City
16 property; and

17 **WHEREAS**, for service of alcohol at events located in locations not specifically
18 mentioned in SFCC 1987, Section 23-6.2(A), the Governing Body must approve a resolution that
19 specifies the event, date, hours, location, number of expected attendees, type of alcohol to be
20 served, permits, and insurance, at least thirty days prior to the event; and

21 **WHEREAS**, the International Folk Art Market (“IFAM”) is an annual event featuring
22 artisans from throughout the world; and

23 **WHEREAS**, IFAM is a significant event benefitting the City of Santa Fe’s tourism
24 industry; and

25 **WHEREAS, 2023 is** the first time IFAM organizers have planned IFAM at the Railyard

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF SANTA FE that alcohol service during IFAM is hereby approved according to the following parameters:

Event: International Folk Art Market.

Dates: July 6-8, 2023.

Hours: Alcohol service may take place from 6:00 pm. to 9:00 p.m. on Thursday, July 6, and from 6 p.m. to 9:00 p.m. on Saturday, July 8, 2023. No alcohol service may occur on Friday, July 7, 2023.

Location: The Railyard Park.

Number of expected attendees: 1,500 are expected in the Railyard Park at any given time during the event.

Type of alcohol to be served: Beer and wine.

Required permits: Special dispenser permit.

Required insurance: Liquor liability insurance in the amount of \$1,000,000.00.


