10 **A RESOLUTION**

11 **AUTHORIZING THE SALE AND CONSUMPTION OF BEER DURING THE PARTY ON**
12 **THE PITCH SOCCER TOURNAMENT ON JUNE 3-4, 2023, PURSUANT TO SFCC 1987,**
13 **SECTION 23-6.2(b).**

15 **WHEREAS**, SFCC 1978, Section 23-6.2 governs the consumption of alcohol on city
16 property; and

17 **WHEREAS**, for service of alcohol at events located in locations not specifically
18 mentioned in SFCC 1987, Section 23-6.2(A), the Governing Body must approve a resolution that
19 specifies the event, date, hours, location, number of expected attendees, type of alcohol to be
20 served, permits, and insurance, at least thirty days prior to the event; and

21 **WHEREAS**, the Santa Fe Adult Soccer League (“SFASL”) held a “Party on the Pitch”
22 tournament at the Metropolitan Recreation Center (“MRC”) in June, 2022; and

23 **WHEREAS**, in the past, SFASL has partnered with Santa Fe Brewing Company to provide
24 a beer garden for players and fans to enjoy during and after games held over the two-day Party on
25 the Pitch tournament; and

1 **WHEREAS**, the SFASL hopes to attract increasing numbers of out-of-city and out-of-
2 state teams to the Party on the Pitch tournament, capitalizing on the ongoing improvements at the
3 MRC.

4 **NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE**
5 **CITY OF SANTA FE** that alcohol service during the Party on the Pitch soccer tournament is
6 hereby approved according to the following parameters:

7 Event: Party on the Pitch Soccer Tournament.

8 Dates: June 3-4, 2023.

9 Hours: 10:00 a.m. to 9:00 p.m. on Saturday, June 3, and 12:00 p.m. (noon) to 5:00 p.m.
10 on Sunday, June 4, 2023.

11 Location: Municipal Recreation Center soccer fields.

12 Number of expected attendees: No more than 50 at a time in the beer garden.

13 Type of alcohol to be served: Beer

14 Required permits: Special dispenser permit

15 Required insurance: Liquor liability insurance in the amount of \$1,050,000.00.


