**A RESOLUTION**

**AUTHORIZING THE SALE AND CONSUMPTION OF BEER DURING THE 2024  
SANTA FE CENTURY AT THE RAILYARD PARK ON MAY 19<sup>TH</sup>, 2024, PURSUANT  
TO SUBSECTION 23-6.2(C) SFCC 1987.**

**WHEREAS**, SFCC 1987, Section 23-6.2 describes the City’s process for approving the  
consumption of alcohol on City property; and

**WHEREAS**, for locations not specifically mentioned in SFCC 1987, Section 23-6.2(A),  
the ordinance requires the Governing Body approve a resolution that specifies the event, date,  
hours, location, number of expected attendees, type of alcohol to be served, permits, and insurance,  
at least thirty (30) days prior to the event; and

**WHEREAS**, the Santa Fe Century (“Century”) is an annual bicycle event that has been  
held since 1985; and

**WHEREAS**, according to the Century’s website, around two thousand (2,000) cyclists  
participate in the Century’s events every year; and

**WHEREAS**, the Century consists of a variety of cycling events for differing abilities that

1 highlight the landscape of northern New Mexico, starting and finishing in downtown Santa Fe; and  
2 **WHEREAS**, the 2024 Century organizers seek to serve beer from the Second Street  
3 Brewery, promoting a local business to the community.

4 **NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE**  
5 **CITY OF SANTA FE** that the sale and consumption of alcohol during the Santa Fe Century is  
6 approved according to the following parameters:

- 7 Event: 2024 Santa Fe Century
- 8 Date: May 19<sup>th</sup>, 2024
- 9 Hours: 9:00 a.m. to 5:00 p.m.
- 10 Location: The Railyard Park
- 11 Number of Expected Attendees: 2,000
- 12 Type of Alcohol to be served: Beer
- 13 Required Permits: Public Celebration Permit
- 14 Required Insurance: Liquor liability insurance in the amount of \$1,050,000.00
