11	APPROVING A PUBLIC FIREWORKS DISPLAY DURING THE BURNING OF
12	ZOZOBRA CELEBRATION ON AUGUST 30, 2024, AND, IF NECESSARY FOR PROPER
13	DISPOSAL, THE DISCHARGE OF UNUSED FIREWORKS ON AUGUST 31, 2024.
14	
15	WHEREAS, the Burning of Zozobra Celebration ("Zozobra") is a beloved and
16	internationally known cultural event that takes place each year in the city of Santa Fe; and
17	WHEREAS, Santa Fe artist Will Schuster created Zozobra in 1924 and the Kiwanis Club
18	of Santa Fe ("Kiwanis") has staged it annually since 1964; and
19	WHEREAS, August 30, 2024 will be the 100 th anniversary of Zozobra; and
20	WHEREAS, the Zozobra organizers utilize fireworks to enhance the event; and
21	WHEREAS, SFCC 1987, Section 12-3.3, "Public Display" requires the Governing Body
22	to approve permits for the public display of fireworks after a permittee applies for a permit with
23	the fire department; and
24	WHEREAS, Ordinance 2024-2 adopted the 2021 version of the International Fire Code
25	which states "the applicant [for a public fireworks display permit] shall file with the jurisdiction a

1	corporate surety bond in the principal sum of \$100,000 or a public liability insurance policy for the
2	same amount"; and
3	WHEREAS, Kiwanis submitted a complete application to the Fire Department to hold
4	Zozobra, requesting that the City of Santa Fe ("City") permit fireworks, and the permit packet
5	includes a Certificate of Liability Insurance which includes general liability insurance in the
6	aggregate amount of two million dollars (\$2,000,000); and
7	WHEREAS, the permit packet proposes to fire the fireworks from the eastbound lane of
8	Murales Road, approximately two hundred (200) feet to the northeast of third base in Zozobra Field
9	at Fort Marcy Park, which is an area within the city limits; and
10	WHEREAS, in the event that there are unused fireworks, Kiwanis wishes to discharge any
11	that are armed in accordance with safety procedures required by the Fire Marshal or Fire Marshal's
12	designee; and
13	WHEREAS, Kiwanis proposes to discharge unused fireworks on August 31, 2024, from
14	Murales Road, on the northeast side of Zozobra Field at Fort Marcy Park; and
15	WHEREAS, the City's Fire Marshal determined in his professional capacity that the
16	planning for the Event, as described by the Kiwanis's application, demonstrates the applicant has
17	taken the appropriate safety measures; and
18	WHEREAS, atmospheric conditions may cause a public safety concern, precluding a safe
19	fireworks display; and
20	WHEREAS, the Governing Body supports the use of fireworks during Zozobra in 2024,
21	to the extent that the use complies with SFCC 1987, Section 12-3, "Fireworks", including the
22	limitations outlined in Section 12-3.9, "Restrictions during severe or greater drought conditions
23	pursuant to Section 60-2C-8.1 NMSA 1978".
24	NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE
25	CITY OF SANTA FE that Kiwanis may set up and discharge fireworks during the Burning of
