1. CALL TO ORDER

A regular meeting of the Public Works/CIP & Land Use Committee was called to order on the above date by Chair Ron Trujillo at approximately 5:00 p.m. in City Council Chambers, City Hall, 200 Lincoln Avenue, Santa Fé, New Mexico.

2. ROLL CALL

Councilor Bushee asked why this was here if it was under \$50,000.

Mr. Drypolcher explained that this amendment bumps the agreement over \$50,000 to \$58,000.

Councilor Bushee surmised that instead of a new contract staff would keep amending it.

Mr. Drypolcher agreed. He explained it had been going on a while in a multi-year arrangement resulting in periodical renewal of the contract and amendments.

Councilor Bushee pointed out that they just approved the watershed agreement and asked if this could be built into that agreement.

Mr. Drypolcher said this is funded from a different pot of money.

Councilor Bushee didn't like amending contracts.

Mr. Drypolcher understood and believed in the future as a more astute project manager it would not be needed.

Councilor Bushee made a motion to approve the request and Councilor Dominguez seconded the motion.

Councilor Dominguez asked what the two different funding sources were.

Mr. Drypolcher said it was through the Water Division with watershed storm water funds for stewardship and clean up and he was not sure what the other source was.

The motion was approved unanimously by voice vote.

11. Councilor Bushee said she took this off originally because it had no FIR. Now we have one. We are paying for insurance, but she didn't know what \$1,800 was for.

Mr. Pino said money was involved because periodically we need to have a crew go out with heavy equipment to help repair the track.

Councilor Bushee asked if the City needs an agreement with them.

Mr. Pino said the City wants to allow them to have control with the MX track. The track the City built has not been satisfactory so we have turned it over to I Ride with their ability to purchase insurance.

Councilor Bushee understood that the City gives them the \$20,000 to buy the insurance.

Mr. Pino said they are a 501(C)3 organization. There were so many issues that ran through the committee so now we are all on board. We are also giving ourselves a cushion for our overtime because this work can only be done on weekends which is an overtime situation.

Councilor Bushee proposed building it into future CIP bond budgets.

Mr. Pino reminded her she had asked us to wean ourselves off of that.

Councilor Bushee made a motion to approve the request and Councilor Dominguez seconded the motion which was approved unanimously by voice vote.

13. MATTERS FROM STAFF

Mr. Pino announced that the first draft of the Pedestrian Master Plan would be available in 1½ months.

14. MATTERS FROM THE COMMITTEE

Councilor Bushee said she continued to get requests from residents on the north side about the big wall there.

Mr. Pino explained this situation was a little different because they were literally against a cliff and that wall was the only way to retain it.

Councilor Bushee said the homes right down on the bottom get dirt all over their sidewalks.

Mr. Pino didn't think they were talking about the same place.

Councilor Bushee clarified that she was talking about lower - east of Gonzales Road. It was right there that she was getting the requests, where people have fancy homes and big walls. She wondered why the people in those homes couldn't finish the work for that area after the City built that nice trail for them.

Mr. Pino said he became aware of that today and it is the first time he heard about that part of the road.

Councilor Bushee said she had been asking about it for a long time and wanted to throw it in the mix and hit up the owners to provide right-of-way at the very least.

Councilor Bushee said she was going to forward some stuff that had been given to her by Canyon Road folks on the same deal.

Councilor Bushee reported there were tons of graffiti on city signs on Calle Vallecita.

Councilor Dominguez wanted an update on the Parks Division Director and a timeline of when some of the stuff will be completed on Airport Road. He thought they had the inmates pulling on the medians and

guessed the City would pick it up.

Mr. Pino agreed. They were continuing on Airport and Rodeo. The inmates pulled the weeds but they cannot bag them. Our guys pick up the weeds.

Councilor Dominguez asked if that already happened.

Mr. Pino said he would check but thought it had.

Councilor Dominguez asked about the rights of way.

Mr. Pino said he would check on that. The Parks Division Director will begin work one week from today. He is from San Antonio and Mr. Pino had a substantial amount of time to visit with him. He seems to be a type to interact easily with people.

Councilor Rivera asked regarding discussion on the sidewalk projects if they would wait a month and a half for the Pedestrian Master Plan to get finished.

Mr. Pino said they could certainly wait. In discussion with Councilor Dominguez the priority was to build off of that master plan.

Councilor Rivera asked the Chair to consider that in building the agenda.

Councilor Rivera suggested in looking into the caboose on the Railyard, to consider making it an art project or something.

Councilor Bushee pointed out that it was City land but Santa Fé Southern owns the caboose.

Mr. Pino said the City rule is that any art in a park is limited to a 6-month stay. Rick Martinez has offered to do a mural on it.

Councilor Bushee said there is an issue of space - after the Acequia Trail.

Councilor Rivera wondered if Santa Fé Southern would be willing to part with it.

Mr. Martinez said they needed to have those conversations with Santa Fé Southern regarding the issue of moving it. It would have to be relocated at some time.

Councilor Rivera asked if the Committee could get some of those questions answered and bring it back to the next meeting.

Mr. Martinez said he was looking to schedule a meeting with them soon.

15. MATTERS FROM THE CHAIR

Chair Trujillo spoke to the number of workers for Fiestas and was thankful that Mr. Pino let them do their jobs.

Chair Trujillo noted that in dealing with weeds, our workers are trying to do their best. He asked if there was any more talk about using vinegar and water as weed killers.

Mr. Pino said there was no further discussion on it.

Chair Trujillo wanted this discussion to keep going for next year. When speaking with some park workers, they would like for Councilors to go out there and spend a day with them. He said he complained about prairie dogs and went to Franklin Mills to work with staff.

Chair Trujillo wished a happy anniversary to Councilor Dimas and his wife.
