A new Section 12-1-5.1 of the City of Santa Fe Uniform Traffic 16 Ordinance is ordained to read: 17 <u>12-1-5.1</u> **AUTOCYCLE.** "Autocycle" means a three-wheeled motorcycle on which the driver 18 and all passengers ride in a completely enclosed, tandem seating area, that is equipped with: 19 20 (1) federal motor vehicle safety standard glazing; 21 (2) a roll cage; 22 (3) safety belts for all occupants; 23 (4) airbag protection; 24 (5) antilock brakes; 25 (6) a steering wheel; and

2	Section 2. Section 12-1-37 of the City of Santa Fe Uniform Traffic Ordinance
3	(being Ord. #2006-34) is amended to read:
4	<u>MOTORCYCLES</u> . Motorcycle means every motor vehicle having a seat or saddle
5	for the use of the rider and designated to travel on not more than three wheels in contact with the
6	ground, including autocycles and excluding a tractor. (66-1-4.11 NMSA 1978)
7	Section 3. Section 12-7-6 of the City of Santa Fe Uniform Traffic Ordinance (being
8	Ord. #2006-34) is amended to read:
9	12.7-6 MANDATORY USE OF PROTECTIVE HELMET.
10	A. No person under the age of eighteen shall operate a motorcycle unless he is wearing a
11	safety helmet securely fastened on his head in a normal manner as headgear and meeting the
12	standards authorized by 66-7-356 NMSA 1978. No dealer or person who leases or rents motorcycles
13	shall lease or rent a motorcycle to a person under the age of eighteen unless the lessee or renter shows
14	such person a valid operator's license or permit and possesses the safety equipment required of an
15	operator who is under the age of eighteen. No person shall carry any passenger under the age of
16	eighteen on any motorcycle unless the passenger is wearing a securely fastened safety helmet, as
17	specified in this section, meeting the standards specified by the [director] secretary.
18	B. Failure to wear a safety helmet as required in this section shall not constitute
19	contributory negligence.
20	C. Autocycles are exempted from the helmet provisions of this Section.

22	Section 4. A new Section 12-7-8.1 of the City of Santa Fe Uniform Traffic
23	Ordinance is ordained to read:
24	12-7-8.1 MOTORCYCLE ENDORSEMENT NOT REQUIRED FOR AUTOCYCLE
25	OPERATION. Autocycles shall be registered as motorcycles and proof of financial

(7) pedals. (66-1-4.1 NMSA 1978)

1	responsibility may characterize them as motorcycles, but a driver shall not be required to have a
2	motorcycle endorsement to operate an autocycle. (66-3-1.4 NMSA 1978)
