6	AMENDING SUBSECTION 12-9-3.9 OF THE UNIFORM TRAFFIC
7	ORDINANCE RELATING TO ADA ACCESSIBLE PARKING VIOLATIONS
8	REQUIRING A MANDATORY COURT APPEARANCE.

10	BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF SANTA FE:
11	Section 1. Subsection 12-9-3.9 of the Uniform Traffic Ordinance (being Ord.
12	#2011-4 (as amended)) is amended to read:
13	12-9-3.9 PARKING IN DESIGNATED ADA ACCESSIBLE PARKING
14	SPACES.
15	A. It is unlawful for any person to park a motor vehicle not carrying registration
16	plates or a placard indicating disability in accordance with Section 66-3-16 NMSA 1978 and
17	Section 3-51-46 NMSA 1978 in a designated accessible parking space for persons with
18	significant mobility limitation or in such a manner as to block access to any part of a curb cut
19	designed for access by persons with significant mobility limitations. Any person who violates
20	this section shall be subject to a fine of not less than two hundred fifty dollars (\$250) or more
21	than five hundred dollars (\$500). Failure to properly display a parking placard or special
22	registration plate issued pursuant to Section 66-3-16 NMSA 1978 is not a defense against a
23	charge of violation of Subsection A of this section (66-7-352.5 NMSA 1978)
24	B. It is unlawful for any person to stand or stop a motor vehicle not carrying
25	registration plates or a placard indicating disability in accordance with Section 66-3-16 NMSA

1978 and Section 3-51-46 NMSA 1978 in a designated accessible parking space for persons with significant mobility limitation. Any person who violates this section shall be subject to a fine of not less than two hundred fifty dollars (\$250) or more than five hundred dollars (\$500). Failure to properly display a parking placard or special registration plate issued pursuant to Section 66-3-16 NMSA 1978 is not a defense against a charge of violation of Subsection A of this section (66-7-352.5 NMSA 1978).

- C. It is unlawful for any person to use a designated accessible parking space for persons with significant mobility limitation for the purpose of receiving or discharging passengers or for loading or unloading if the vehicle receiving or discharging the passengers or loading or unloading does not carry registration plates or a placard indicating disability in accordance with Section 66-3-16 NMSA 1978 and Section 3-51-46 NMSA 1978. Any person who violates this section shall be subject to a fine of not less than two hundred fifty dollars (\$250) or more than five hundred dollars (\$500). Failure to properly display a parking placard or special registration plate issued pursuant to Section 66-3-16 NMSA 1978 is not a defense against a charge of violation of Subsection A of this section (66-7-352.5 NMSA 1978).
- D. As used in this section, "designated accessible parking space" means any space including an access aisle, marked and reserved for the parking of a vehicle that carries registration plates or a parking placard indicating disability in accordance with Section 66-3-16 NMSA 1978 and Section 3-51-46 NMSA 1978, and designated by a conspicuously posted sign bearing the international symbol of accessibility and if paved, by a clearly visible depiction of this symbol painted white on blue on the pavement of the space, except where the total number of parking spaces is four or less. Temporary accessible parking spaces may be designated by a blue hood labeled as accessible parking or in such other manner as to clearly indicate the space is for accessible parking only. "Curb cut" means a short ramp through a curb or built up to the curb designed for access by persons with disabilities. (66-7-352.5 NMSA 1978).

1	E. Any vehicle parked in violation of Subsections A, B or C of this section is
2	subject to being towed at the expense of the vehicle owner upon authorization by law
3	enforcement personnel or by the property owner or parking division director.
4	F. State, county and municipal law enforcement personnel, including city of Santa
5	Fe parking enforcement officers, have the authority to issue citations for violations of §12-9-3.9
6	in their respective jurisdictions, whether the violation occurs on public property or private
7	property (Section 3-51-46 NMSA 1978).
8	G. A law enforcement officer may issue a citation or authorize towing of a vehicle
9	for a violation of Section A of this section regardless of the presence of the driver (66-7-352.5
10	NMSA 1978).
