AUTHORIZING AN AMENDMENT TO THE 2008 GENERAL OBLIGATION (GO) BOND

TO REALLOCATE \$803,000 CURRENTLY DESIGNATED FOR VARIOUS CITY PARK IMPROVEMENTS TO COMPLETE CERTAIN **INCOMPLETE PROJECTS** CITY PARKS AND RECREATION FACILITIES AND TO REPLACE THREE FAILING

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF SANTA FE:

Section 1. Authority

BRIDGES AT FORT MARCY PARK.

- Section 11-9.1(E) SFCC 1987 requires that any reallocation of proceeds from a A. voter-approved general obligation bond that deviates materially from the information provided to the electorate by the city of Santa Fe shall be voted upon by the governing body through the adoption of an ordinance.
- The governing body, through the adoption of this ordinance, authorizes the B. reallocation of funds from the 2008 parks bond as specified in Section 3 of this ordinance.

Section 2. **Legislative Findings**

- The 2008 General Obligation Bond was approved by voters in the amount of A. \$30,300,000 on March 4, 2008.
- Many of the projects that were to be funded by the bond have been completed, B. while others are in progress or waiting to be started pending reallocation of unspent funds.
 - C. A reallocation of bond funds is requested to address certain safety concerns and
