11	ADDING THE CANYON ROAD LIGHTING, STREET AND SIDEWALK SAFETY
12	PROJECT TO THE FISCAL YEAR 2017/18 CAPITAL IMPROVEMENT PLAN (CIP)
13	FOR THE CITY OF SANTA FE TO ADDRESS BOTH PUBLIC AND TRAFFIC SAFETY
14	ISSUES ALONG CANYON ROAD.

16	WHEREAS, inadequate standard street width and inconsistent sidewalks cause
17	pedestrians to walk on the street; and
18	WHEREAS, the city typically utilizes street lighting for traffic safety purposes and may
19	now be compelled to also consider public safety when determining where street lighting is
20	required; and
21	WHEREAS, the Canyon Road Merchants Association requested street lighting in the
22	Canyon Road business district for public safety purposes at a meeting with city representatives in
23	2014; and
24	WHEREAS, in 2014, a Canyon Road street lighting project was programmed in the ICIP
25	as an unfunded capital project and formally designated as a Council District # 2 legislative capital

1	priority until it was removed from the ICIP in 2016; and
2	WHEREAS, this recent criminal activity, just prior to the popular Farolito Walk along
3	Canyon Road, required the Canyon Road Merchants Association to hire a private security company
4	to maintain a presence along Canyon Road and serve as a deterrent to further criminal activity; and
5	WHEREAS, supplemental funding for this street lighting project [should] may be sought
6	from legislative capital outlay sources through its inclusion in the City of Santa Fe's Infrastructure
7	Capital Improvements Plan (ICIP);
8	NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE
9	CITY OF SANTA FE that the Canyon Road lighting, street and sidewalk safety project is hereby
10	added to the CIP.
