5	five (5) tons are not prohibited provided the following are met:
6	(1) The vehicle is making pick-up and deliveries or providing services to
7	addresses on the specific streets or to addresses on adjacent streets served only by that
8	specific street(s); or
9	(2) The vehicle is traveling to or from such addresses for the purposes of
10	locating permanently or temporarily at such addresses provided they are in compliance with
11	any other applicable city code.
12	C. Authorized emergency vehicles; any government or utility maintenance, service and
13	transportation vehicles; and school buses, with a gross vehicle weight of five (5) tons or more, are
14	permitted to travel on the streets specified above.
