MINUTES

1) Call to Order

Ms. Alejandra Seluja, Chair, called the Immigration Committee meeting to order at 4:30 pm. A quorum was declared by roll call.

2) Approval of Agenda

Ms. Ugalde-Alcazar moved to approve the agenda as amended from 2012 to 2017, second by Ms. Guerrero, motion carried by unanimous voice vote.

3) Approval of Minutes – January 3, 2017

Correct spelling for Ms. Susan <u>Hayre</u> – on the National Welcoming Committee Program

Ms. Lopez moved to approve the minutes of January 3, 2017 as amended, second by Ms. Hayre, motion carried by unanimous voice vote.

4) Community Comments

Ed Moreno, Newly Elected Santa Fe County Commissioner

Mr. Moreno will be attending the meetings on behalf of Santa Fe County.

Julia may attend if schedule gets busy. Committee members expressed their thanks to Commissioner Moreno for attending.

Janet – Observing.

Mariana – Program Director who work with immigrant children at the public schools who need assistance regarding loss due to deportation. They serve about 100 children at this time. Safe Space is a place where the community can come and express their concerns. For example, Allegra Love shares up to date information and it gets communicated weekly at Ortiz School from 6-8 pm on Friday evening. One of the activities they have during safe space night is they can play soccer for the children and the parents most times accompany them and we share information with them. There are mainly teenagers and around 50 are now attending. This is a space where they can safely express their concerns. This program was created by Santa Fe Public Schools and goes hand in hand with the Sanctuary Resolution that was passed by the Santa Fe School Board. All spaces at the school are safe spaces and ICE is not admitted.

5) New Business / Action Items

a) Guadalupe Credit Union Presentation

The date and time of the Juntos Avanzamos Fair will be held March 10, 2017 from 2:00 pm - 7:00 pm. (Exhibit Attached)

Juntos Avanzamos has national recognition as a Safe Space and are offering the fair so those who participate will feel safe. She noted that approximately 700 people go through the branch offices on Friday's. The Mexican Consulate will be in attendance along with SOMOS, Christus St. Vincent, Allegra Love, Mujeres Adelante, Accion and the Santa Fe Police Department. It was also noted that they are going to offer this fair in Espanola in the near future.

Ms. Diaz said that there were about 40 families in Espanola and it was very organized. They were able to meet with the Mayor in Espanola and it was noted that Espanola has stronger sanctuary policies. Guadalupe Credit Union members were great. There are strong policies in the books. Ms. Diaz said thank you on behalf of the Immigration Committee and SOMOS.

Diane Sandoval-Griego, Financial & Education Outreach Coordinator Ms. Rodriguez – Works for Guadalupe Credit Union and does outreach for Hispanic community.

The Chair noted that Guadalupe Credit Union was the first to receive the National Designation in the Country. It was started in Texas at that time for the Credit Union league. They found that institutions that are serving Latino, Hispanic, Immigration communities – they launched this program and Guadalupe Credit Union was the first to offer the services. Juntos Avanzamos is working with the immigration population to let them know where they can receive services and know that they are protected. There is now another financial institution in Albuquerque with this rating.

Ms. Diaz moved to endorse the Juntos Avanzamos Fair by the Immigration Committee in an unofficial capacity and attend this event, second by Ms. Hayre, motion carried by unanimous voice vote.

Deputy Chief Salbidrez asked the committee if they were aware of NAMI, they should be invited if at all possible. This is a program for families who have mental illness. The SFPD and SFFD are there to help them whenever they have a crisis. The Mobile Crisis Team is the group that provides the services. Services are free. Commissioner Moreno also talked about their mobile unit and asked that Mr. Sanchez reach out to Rachel O'Connor at Santa Fe County for more information.

b) Approval of Discussion Items for the City Council Presentation

Exhibit B – This document was sent to the City Manager on behalf of the Immigration Committee. The Chair noted that these are the items that she will update the City Council also committees that have been created and future goals. The Chair confirmed that this document was sent in the past to the City Manager and she asked for updates from the committee members.

Additions:

Ms. Diaz – It is very clear that we are an advisory committee. We can add recommendations that have been made in the last two years where they can enumerate the recommendations. A lot of votes are taken on recommendations and this way they don't get lost in other categories. It is good to keep record of what is presented to City Council.

It was noted that the correct dates should be reflected when presented to the City Council. Mr. Sanchez said that this process will take place for the next 2-3 months as all Boards and Commissions have to present to the City Council.

Ms. Guerrero recommended that the Chair look at past sets of minutes that reflect information.

The Chair will send out a final draft to the committee members for an approval at a later date.

Ms. Diaz moved to table the approval of the City Council Presentation document to a later date, second by Ms. Hayre, motion carried by unanimous voice vote.

6) Old Business

a) Subcommittee Updates

• Welcoming Communities – Ms. Marcella Diaz

Ms. Diaz noted that they are in communication with the City requesting approval of their membership in the Welcoming Committee. They would like to announce, although not coming directly from the committee, there was a Memorial that was dropped yesterday in the NM Senate that they worked with Senator Martinez from Rio Arriba County on police policies, sanctuary policies, jail policies, etc. They would have a lot to lose from the Trump Administration on non-discriminatory

policies at a city and county level. His memorial talks about all the costs, both economic, social and familial costs of these executive orders if they were actually implemented and funded, what they would cost our community. Ms. Diaz said they wanted to use it to educate local policy makers; we have a 10th Amendment right to basically determine how we use our local resources. One of the things that it says (Ms. Diaz will send the study to the Immigration Committee members), they took a look at 500 communities in the country that have policies that insure that local municipalities including law enforcement are not sharing immigration status with ICE or not doing the work of ICE. When they did that study it was found that crime has gone down in those communities. Not only are we saving ourselves from lawsuits; people are feeling safe. Basically it is asking the Legislature to take a strong stand against the policies, getting good legal information to our city and counties on what our authorities are. The Memorial backs ups the policies we have for sanctuary communities. They are asking the Attorney General and the State Auditor to provide information on immigration law. It also urges Congress not to fund such a thing as building a wall. Ms. Diaz stated that our State Constitution is more extensive than the Federal Constitution when it comes to protecting vulnerable minorities.

Ms. Diaz made reference to the non-discrimination and protecting confidential information resolution. They went back and looked at the City Charter, which also is more expansive in protecting vulnerable minorities. One of the things that it says very clearly and it was voted upon by the people of Santa Fe, it says "our city will not adopt any policies, not adopt any ordinances, will not condone any laws, policies or ordinances that discriminate against people based on race, color, disability, LGBT status, national origin and citizenship status."

Mr. Sanchez said he will be carrying the Legislation, Finance Committee will meet on February 13th at 4:00 pm, February 21st is Public Safety Committee and 22nd is City Council. Mr. Sanchez urged the committee to attend.

Ms. Diaz is working with the New Mexico TRD to ensure that people are not finger printed as they have been given incorrect information for their driver's licenses. Many local citizens expressed their concern to the legislators that they have been given incorrect information.

• Education – Amparo Guerrero

Ms. Guerrero noted that her sub-committee is conducting the Multicultural Community Forum on Thursday, February 9, 2017. It will be held at Sweeney Elementary School fro 5:00pm – 7:00pm. (Exhibit C)

Maria Cristina Lopez paid tribute to Cara Esquibel who before her passing worked very hard with Santa Fe Public Schools on this program and to work with the parents to advocate for their kids.

• Social Media & Communications – No Report

• Refugee Resettlement – Javier Rios

Mr. Rios reported that Ms. Hemmer met with Father Adam at the Cathedral and will attend a future meeting with the Ecumenical Council regarding the refugee resettlement. Ms. Lopez said her recollection is that the Mayor is very interested in working with the refugees in our community. Ms. Lopez said perhaps this committee could write up a resolution or memorial where we would explain the suffering of our immigrants and provide support of the Immigration Committee. The Chair said we did that with the Driver's License matter. The Chair asked that we add Refugee Resettlement as an action item for the next month meeting and in the interim create the wording.

Ms. Lopez proposed that the Immigration Committee organize/sponsor a legal clinic. Immigrants, refugees have many questions and if this committee could orchestrate this type of function, it would be extremely helpful. Ms. Diaz said that through SOMOS they are in discussion to do something like this and she recommended that the Immigration Committee be invited to participate. Their plan is to hold an event of this type in the month of March. The goal is to get the city involved with those entities that are doing the work. It would be a Legal Clinic/Know Your Rights Forum in conjunction with the four entities of Government who have expressed their support.

• Police Department – Deputy Chief Salbidrez

Chief Salbidrez asked for help and support on crime prevention – a report from the NICD on stolen vehicles reports that Bernalillo County (Albuquerque) is second in the nation for stolen motor vehicles and we get that residual effect that these criminals will come in to our community. We felt that in 2016. The Santa Fe Police Department has mailed out over 11,000 flyers to residents in the south side of town advising them about stolen motor vehicles. The SFPD has noted that stolen motor vehicles are coming from the south side of town where individuals are heating up their vehicles and it becomes an easy steal. Burglaries in the state of New Mexico were #2 in the Nation. We need support and watchful eyes for these thieves, as a Police Department we cannot do it alone. We need your help.

Chief Salbidrez was pleased to report on the UVisa Policy, "The item has been posted for the Union to review. 10 days from now, if everything goes well we will then adopt it as a City Policy and that will be approximately February 17, 2017 and it will become Policy 101 added to our books."

It was noted that UVisas have been issued utilizing Best Practices until it becomes a policy. It can be seen once it is approved and released. Ms. Diaz wanted to know if it could be sent to the Immigration Committee for review. Chief Salbidrez said that it has already been approved and reviewed by Legal. If the Committee plans to render or offer small changes it can be done after it becomes a Policy. Ms. Diaz added that part of what the Immigration Committee does is review policies. The Immigration Committee is normally being offered an

opportunity to review policies. Chief Salbidrez said that Immigration Committee has had that opportunity earlier in the process and it has been vetted by the Chief of Police and Legal. Dynamic documents can always be changed.

b) Update on Sanctuary City Resolution

Ms. Diaz said they are taking out the word Sanctuary because there is no legal definition for what Sanctuary is. There are several attorneys that are interested in representing the city if and when there is a challenge on any policies if the wording is clear. Ms. Diaz said that our policies need to be put in a more legal, defensible language and make them as strong as possible. We took out the word sanctuary and talked about what the resolution is going to do and not do.

7) Comments from the Chair and Committee Members

The Chair read the sentiment wording for the plaque for Cara Esquibel, which will be in Spanish as she would have liked. This will go hand-in-hand for the Proclamation. Mr. Sanchez said he would need help with the wording for the Proclamation and together set the date for the reading and presentation at City Council.

Ms. Diaz said that her students would like to attend. Her birthday was on July 17th – it would be easier to do it a date earlier when her students and schools are still in session. July 17th could be her day – but presentation possibly around her anniversary date. More information to follow.

8) Report from Staff

a) Proclamation for Cara Esquibel

Mayor Gonzales would like to issue a proclamation, Cara Esquibel Day in March and invite her family and present them with a plaque that they have in her memory and hard work.
