12	BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF SANTA FE:
13	Section 1. Section 7-1.1 SFCC 1987 (being Ord. #2008-1 (as amended)) is
14	amended to read:
15	7-1 BUILDING CODES; GENERAL PROVISIONS.
16	7-1.1 Adoption of Codes.
17	A. For the purpose of regulating the erection, construction, enlargement, alteration,
18	repair, moving, removal, conversion, demolition, occupancy, equipment, use, height, area,
19	unobstructed maintenance of required yards, and maintenance buildings or structures within the
20	planning and platting jurisdiction of the city, the following provisions and codes are adopted by
21	reference and incorporated as fully as if set out herein unless otherwise amended by the city:
22	(1) Section 14.5.1 New Mexico Administrative Code (NMAC) General
23	Provisions;
24	(2) Section 14.5.2 New Mexico Administrative Code (NMAC) Permits;
25	(3) Section 14.5.3 New Mexico Administrative Code (NMAC) Inspections;

1	(14) 2012 Uniform Solar Code as amended by the state of New Mexico
2	construction industries division referred to as the 2012 New Mexico Solar Energy Code
3	(NMAC 14.9.6);
4	(15) 2014 National Electrical Code as amended by the state of New Mexico
5	construction industries division and referred to as the 2014 New Mexico Electrical Code
6	(NMAC 14.10.4); and
7	(16) 2012 National Electrical Safety Code as amended by the state of New
8	Mexico construction industries division as amended by the state of New Mexico and
9	referred to as the 2012 New Mexico Electrical Safety Code (NMAC 14.10.5);
10	B. Any person violating or failing, neglecting or refusing to comply with the
11	provisions of the codes set forth in paragraph A. above or this chapter shall be punished as
12	provided for in Section 1-3 SFCC 1987.
13	C. A copy of the codes set forth in paragraph A. and this chapter shall be kept on file
14	in the office of building inspections, and shall be at all reasonable times available and subject to
15	inspection.
16	D. The codes set forth in paragraph A. shall be effective ten (10) days from the date
17	of adoption of this ordinance. Upon request of the applicant, applications for permits submitted
18	before six (6) months prior to the effective date may be issued in compliance with the prior codes.
