1. CALL TO ORDER

Chair Colin Messer called the meeting of the Transit Advisory Board to order at 5:04 p.m. at the Santa Fe Trails Facility, 2931 Rufina Street, Santa Fe, NM. A quorum was established with roll call.

3: APPROVAL OF AGENDA

<u>MOTION:</u> Mr. Cooper moved to approve the agenda as presented with a second from Ms. Bleck which passed by voice vote.

3. APPROVAL OF MINUTES FROM APRIL 25, 2017

MOTION: Ms. Bleck moved to approve the minutes as presented with a second from Ms. McGinnis which passed by voice vote.

4. PUBLIC COMMENT

There was not any public comment.

5. ACTION ITEM

1. APPOINTMENT OF ADA APPEALS SUBCOMMITEE MEMBERS

Ms. Amador explained there is a subcommittee to handle ADA appeals. There needs to be one more TAB member appointed. There will be a paratransit employee present as well. There is an appeal hearing scheduled tomorrow at 5:30 p.m.

Chair Messer has volunteered to be the third member for tomorrow's hearing but suggests an alternate be chosen. The handbook was referenced.

Ms. Amador explained this is the first appeal she has seen since she has been at Transit.

<u>MOTION:</u> Mr. Cooper moved to have Ms. McGinnis, Ms. Bleck, Mr. Messer and Ms. Mazares (as an alternate) to be the members of the TAB ADA Subcommittee, with a second from Ms. McGinnis which passed by voice vote.

Mr. Wilson explained the timeline and the reason they needed to have the hearing tomorrow evening.

6. DISCUSSION ITEMS

1.FY 17/18 BUDGET UPDATE

Mr. Cooper drew a pie chart and asked that the revenues be shown so the board can see how the budget is divided.

Mr. Wilson explained the Finance committee and City Council passed the budget for next year unchanged. The amount is roughly 12.7 million which includes money for new buses.

Mr. Wilson stated there are some low emission grants they will try to get matched. However it is competitive nationwide. He will make a formal chart and get the information exact for the board.

Mr. Wilson explained the percentages Transit is getting from the GRT and Federal funds. The passenger revenue and rebates for clean energy contribute as well.

After the triennial in July they can look at the budget better.

A discussion was held about rerouting plans. Mr. Martinez stated they are holding onto to money for that specifically. Mr. Wilson stated once the contract is finalized with Transloc they can have data entered that could help with the rerouting process. They will get input from the drivers.

Chair Messer asked how that data will tie in with what the SFCC is doing. Mr. Martinez stated it should tie in well. There needs to be an update in technology.

A discussion was held about the closing of Capital City Cabs and the affect is has on the ridership now. Mr. Thompson informed the board that a larger company bought Sandia Shuttle.

2.2018 NCRTD AND TRANSIT SERVICE PLAN

Mr. Wilson explained the Resolution that would add routes 22, 4,2 and add the five annual specials. (See Exhibit A)

Mr. Wilson explained the portion of the agreement that will include the ski route. The service will reduce when the ski season ends. Mr. Wilson explained how NCRTD keeps a tally of their routes and ridership.

A brief discussion was held on how to pass this item to the next committee. Mr. Wilson explained it doesn't need a vote necessarily.

MOTION: Mr. Calvert moves to recommend approval as written, with a second from Ms. Bleck which passed by voice vote.

Ms. Bleck asked about the consolidation study. Mr. Wilson explained it is still going on. They received some draft documentation and consolidation options but they weren't very specific. He will try to get some more information for the next meeting.

3. VETERANS TRANSPORTATION AND COMMUNITY LIVING INITIATIVE GRANT

Mr. Wilson explained there was a grant in 2013. (See Exhibit B) There is still an amount needed to be spent but it has to be spent on electronic items before September 30th. They will use it to purchase some of the GPS units requires by Transloc.

If there is enough leftover they can link the units to the fare boxes. Mr. Wilson explained approval will go to City Council in July. They hope to have Transloc tested and still use Routematch until November when their contract runs out.

Mr. Martinez discussed an electronic work order system. A committee was formed and IT is now working on software that will help.

<u>MOTION:</u> Mr. Calvert moves to approve the remainder of the grant money to be used for the GPS units and other technology with a second from Mr. Thompson which passed by voice vote.

4. CNG FACILITY UPDATE

Mr. Martinez stated they were hoping to have the RFP out by the end of June. They want to have it done just right with the options they will need. They would like the option for the station to be owned by the City within eight years.

5. SOUTHSIDE TRANSIT CENTER UPDATE

Mr. Wilson reported that they are at 95% design now. They would like to have the final design by next month, then it can go out for bid.

A discussion was held about the Santa Fe Place mall. Mr. Wilson explained that their consultant contacted him and asked for a timeline on the Southside Center. The owners of the mall would still like service

through the mall area. Mr. Wilson explained to the consultant that they were working on options assuming they didn't want them to go through the property at all.

Mr. Wilson stated they will meet again to discuss further options.

6. DOWNTOWN SHERIDAN TRANSIT CENTER UPDATE

Mr. Wilson stated he still has not received final word on the environmental report downtown. A discussion was held about SHPO and their concern with digging to move the sewer lines. He hopes to get things started before winter.

7. STAFFING UPDATE

Mr. Martinez reported there were interviews for the last paratransit driver. The listing for a fixed route supervisor will close next week. Mr. Martinez stated the administrative assistant is in the hiring process. The shop is fully staffed and working well.

8. SYSTEM RIDERSHIP-FIXED ROUTE, PARATRANSIT, AND SF PICK UP

Mr. Martinez presented the system ridership report (See Exhibit C). The amount has gone up quite a bit since the closing of Capital City Cabs.

Mr. Thompson noticed there is a spike every other Wednesday.

9. CUSTOMER COMMENT/COMPLAINT SYSTEM

Mr. Martinez presented the complaint report. (See Exhibit D) If there are any outstanding he will get them closed out. Mr. Thompson asked about route 2 seems to have the same complaint of a rude driver. Mr. Martinez explained that route is the busiest route and it gets the most complaints.

10. OPERATIONS AND MAINTENANCE

Mr. Martinez reported the work was complete on the Arboc and is on the road again. (See Exhibit E)

8. PUBLIC COMMENT

There was not any public comment.

9. ADJOURN

Chair Messer briefly discussed the letter written by Ms. Bleck regarding the intersection at Cerrillos Rd. and Second Street. Mr. Wilson stated the MPO has the letter as well. Mr. Wilson stated NMDOT is at 60% design over the next few months they will coordinate the Indian hospital to approve right of way for the improvement. The estimated cost so far is 2.5 million.

MOTION: There being no further business to come before the Transit Advisory Board Mr. Calvert moved to adjourn the meeting at 6:31 p.m. with a second from Mr. Thompson which passed by voice vote.

Maestas 5 6 7 8 9 10 **A RESOLUTION** 11 ENDORSING THE NORTH CENTRAL REGIONAL TRANSIT DISTRICT'S FY2018 12 BUDGET PROPOSAL, APPROVING THE FY 2018 CITY OF SANTA FE REGIONAL 13 TRANSIT PLAN AND DIRECTING STAFF TO SUBMIT THE CITY OF SANTA FE 14 REGIONAL TRANSIT PLAN FOR FY 2018 TO THE NORTH CENTRAL REGIONAL 15 TRANSIT DISTRICT BOARD OF DIRECTORS FOR CONSIDERATION AND APPROVAL. 16 17 WHEREAS, the North Central Regional Transit District (hereinafter referred to as 18 "NCRTD") was created in 2004 by agreement between the City of Espanola, Los Alamos County, 19 Pojoaque Pueblo, Rio Arriba County, San Ildefonso Pueblo, San Juan Pueblo, Santa Clara Pueblo, the 20 City of Santa Fe, Santa Fe County and Tesuque Pueblo; and 21 WHEREAS, NCRTD Resolution 2008-14 states that "in order to create a truly effective and 22 efficient regional transit system that cooperatively and equitably serves north central New Mexico, 23 the NCRTD believes that the City of Santa Fe should be a member of the District"; and 24 WHEREAS, as a result of City of Santa Fe Resolution 2008-87, the City of Santa Fe joined 25 the NCRTD and soon thereafter expanded City delivered transit services to provide connecting 26 transportation to and from the Rail Runner, through funding made available by the NCRTD; and

- Additional enhanced, or "special service", provided to accommodate visitors and residents alike, and meet increased demand for Rail Runner transfers, on Folk Art Market, Spanish Market, and Indian Market weekends, as well as annual community celebrations of Zozobra and the Canyon Road Farolito Walk;

WHEREAS, the existing services provided by Santa Fe Trails have been deemed to meet the definition of regional services as adopted by the NCRTD Board and incorporated into its financial policies as amended on November 4, 2011 by Board Resolution No. 2011-10; and

WHEREAS, the NCRTD has identified funding in their FY 2018 budget proposal to keep the aforementioned regional services, operated by the City, funded and running through FY 2018; and

The City of Santa Fe has been appropriated \$52,000.00 in Federal Transit Administration (FTA) §5309funds through the New Mexico Department of Transportation (NMDOT), Transit & Rail Division, the designated recipient of these FTA funds for the State of New Mexico. In order for the City to be awarded these funds, a Memorandum of Agreement (MOU) must be executed with NMDOT.

BACKGROUND

Section §5309 provides for financial assistance for the purchase of capital equipment. The Transit Division intends to use this appropriation to purchase capital equipment for Transit. The funds will be used to purchase GPS Transponders for buses, equipment to connect the fare box system to the GPS, iPads to run the On-Demand service within the Transit and Para Transit vehicles, and to purchase software for the implementation of the application.

We were contacted by NMDOT informing us that the original contract extends back to 2013 and that we still had not spent the money and that funds are still available. The MOU is a one year agreement from April 1, 2017 to September 30, 2017. The local match for this grant is \$13,000.00.

BUDGET

As reflected in the attached Budget Adjustment Request, the revenue business unit/line item will be 51416.490150 (NM Dept. Trans) \$62,000.00 and the expense business unit/line items will be 52416.571900 (Equipment & Machinery>\$5,000) \$65,000.00. The local match amount of \$13,000.00 is in cash in the fund (5416).

Dear Mr. Tibbetts:

A Road Transfer Agreement for NM14/Cerillos Road between the City of Santa Fe and the New Mexico Department of Transportation hasn't happened in over a decade and may never happen. It is currently not anticipated in at least the next four years. This lack of a "Road Transfer Agreement" is not an excuse for the NMDOT to delay once again making the bus stop in front of the Indian Hospital at Cerillos Road and Second Street accessible.

NMDOT has actually admitted that they have the responsibility to meet ADA standards at the bus stop in front of the Indian Hospital in advance of the Road Transfer but lack funding for the project. Whatever other projects are needed in District 5 over the next two years, by law, this project must be given priority. If current District 5 funding is not adequate, the State of New Mexico must find the money out of reserves or other emergency funding.

We are writing this letter as citizens of Santa Fe. You will see from the enclosures how unresponsive the NMDOT has been to this accessibility problem in front of a medical facility and a school that serve members from minority populations and

persons with limited resources. To prove Title 1, 2, and 6 violations of U.S. law, one only has to put pictures of the bus stops from different facilities side by side.

Plans to make the intersection at Cerillos Road and Second Street accessible are partially (30-60%) drawn [Santa Fe County SP-5-16(385) CN M500887] because a start date of July 2017 was promised last year (see 2016 enclosures) and a cost estimate has been made. To save costs, only the two south corners of the intersection need to be made accessible. The two corners on the north would be curb cuts to nowhere because there are no passable sidewalks there anyway. A pull-in/pull-out bus stop as requested by the City of Santa Fe also seems unnecessary if that requirement prevents a timely remedy that will work for persons using wheelchairs and scooters.

We are not the only two people in Santa Fe who care about people who use wheelchairs and scooters and might need medical care. By copy of this letter, the FHWA is hereby notified of our stance on this issue. The Mayor's Committee on Disability and the Transit Advisory Board are also monitoring this breach of responsibility by the NMDOT.

There can be no more excuses on this project to provide accessibility as required under the ADA. The Road-Transfer-Agreement excuse expired several years ago with the repeated (and now continued) postponements of the transfer plans. NMDOT has agreed that they MUST fix this intersection. There are no excuses that justify further delay. This project needs to be fixed this summer, and we as citizens will call upon fellow citizens, friends and media contacts to help keep the NMDOT accountable for a timely remedy.
