MEETING Santa Fe, New Mexico

February 13, 2018

The informational meeting of the City of Santa Fe Human Services Committee was called to order by Marizza Montoya-Gansel, Chair at 2:00 p.m. at Market Station Offices, 500 Market Street, Conference Room, Santa Fc, New Mexico.

Roll Call indicated that there was not a quorum present for conducting official business; therefore, an informational meeting was held.

Chair Montoya-Gansel said the Committee cannot have an official meeting because they do not have a quorum. An informational meeting was held.

Introductions were made.

APPROVAL OF AGENDA

Approval of the Agenda was not made due to the lack of a quorum.

<u>APPROVAL OF MINUTES</u>: December 12, 2017 meeting January 12, 2018 meeting

Approval of the Minutes for the above meetings was not made due to the lack of a quorum.

NEW BUSINESS/ACTION ITEMS:

a. Discuss and Recommend Approval: A RESOLUTION ESTABLISHING A HOMELESSNESS TASK FORCE

[Copies of the Resolution were distributed. A copy is hereby incorporated with these Minutes as Exhibit "4a".]

Chair Montoya-Gansel asked Mr. Hughes if they wanted to make a presentation or discuss the Resolution with the Committee.

Mr. Hughes said they don't have anything prepared, but they could say a few things. He said they had two other task forces about homelessness. The first one was in 2007 and then again in 2012 to develop community-wide plans to work on ending homelessness and they thought it was time to do that again.

Ms. Tang said those were very successful.

Mr. Hughes said yes, they were very successful and they made a lot of progress – the groups in this room made a lot of progress. They have a lot more housing for people; they have the Day Center that is open three days a week-and they hope to expand on that.

Mr. Hughes mentioned that he Chaired the two last committees and that is why he asked Mayor Gonzales if they could do this again. He said the other plan was successful and they would probably want to come up with another 5-year plan and make recommendations to City Council on what they could do to help them address homelessness, even more effectively than the other.

Ms. Tang noted that they have already had three preliminary meetings.

Mr. Hughes said right, they have been meeting with City staff in a preliminary way about this idea.

Ms. Sanchez said the Resolution was on the Public Works Committee's agenda last night and it passed. It did not get pulled from the Consent Calendar, so it will go to the Finance Committee and then to City Council at the end of this month.

Ms. Boies asked if the members from the public were present for this and they said yes. She mentioned that she received the Resolution last night so she is reviewing it now and she did not see any recommendations from before.

Ms. Boies said she had a couple of questions on the Resolution: Page 3 under "Duties and Responsibilities" and said she would like to read it because it has language that she really does not know what it means. It states: "The task force shall consider and develop a strategic road map that outlines the purpose above (and the purpose above is to make recommendations to the City of Santa Fe in an effort to make homelessness rare, brief and non-recurring) and works from a "Hub and Spoke" holistic model to provide stability and platform growth from being homeless to independence for our homes population throughout Santa Fe."

She asked Mr. Hughes what he meant when he said they have had preliminary meetings with staff.

Mr. Hughes said Julie Sanchez, Chris Sanchez and Alexandra Ladd.

Ms. Boies said in the last couple of months, there has been an informal working group on housing generally, and also rental housing, and Joseph Montoya and Alexandra Ladd have been chairing that, and she has been attending that.

She asked what a "Hub and Spoke" holistic model is and she does not know what "platform growth" means.

Ms. Tang said she does not know about "platform growth" but there is a one-door group, and she is part of that group, who is working on trying to find a location where many different agencies could work from, kind of like a one-stop, but larger than what they have right now. She said it is more of a campus-type concept where there would be shelter and services provided, such as healthcare, respite care and all those types of things, all in one location. Not all providers would have to be located there, they could send somebody, but it would be a place where people can make connections with other agencies and that's what she thinks the "Hub and Spoke" means.

Mr. Hughes noted that none of them wrote that.

Ms. Sanchez said Ms. Tang is correct. The Hub and Spoke is a holistic transitional-housing model that actually came out of youth transitional services - from an agency who did research for youth transitional models. They found that if you have services that are serving youth within the same space that the youth is occupying, there is much more success of that youth being able to transition successfully into permanent housing with wraparound services.

She said this is where it came from and one of the City Councilors really wanted to include that language because they want to make sure they are setting up homeless clients/homeless participants up for success. This is a model that the City would be looking at through this Resolution.

Ms. Boies said she understands the services and that people can come from various places, but did they also say that this also entails actual people living there. She asked if the Hub includes living quarters for a certain number of people.

Ms. Tang said yes.

Ms. Sanchez said the Resolution is looking at the entire landscape of the homeless arena and doing an evaluation of what the strengths, opportunities and threats are in the community, and see how they can build programs that are client-centered and see how they can do this collaboratively and work with the groups that are represented here today.

Ms. Sanchez mentioned that the Task Force has six months after the adoption of the Resolution to come up with a plan and provide recommendations or an overall report on the designated items. She said the Task Force will hold monthly meetings and will be looking at other models that other cities are doing, and see how they would be applicable within the City of Santa Fe.

Chair Montoya-Gansel asked if they could change the language in the Resolution.

Ms. Sanchez said yes, the Committee can make suggestions and that is the reason why this Resolution came before the Committee.

Chair Montoya-Gansel asked if six months is enough time.

Mr. Hughes said yes, he thinks so. They were planning to do most of this in one meeting where they can get all the participants together and have a facilitator conduct the meeting. It should not take that much time after the meeting to put the plan together.

Ms. Boies said in looking at the Fiscal Impact Report, she noticed funding for a stenographer but you mentioned having a facilitator too.

Ms. Sanchez explained that the Task Force would fall underneath the Youth and Family Services Division and they do have funding set aside for a facilitator and this will come out of their budget and not out of the City's General Fund.

Ms. Boies asked why this is on the Committee's agenda, is the Committee asked to provide feedback.

Ms. Sanchez said yes, and the Committee is also asked to approve the Resolution moving forward.

Chair Montoya-Gansel said the Committee cannot approve the Resolution today because they do not have a quorum.

Ms. Sanchez said they could have discussion and if there are any suggestions on the language or clarification, she can take this back to the Legislative Liaison's office.

Ms. Boies said it might be helpful to have more of a description of what a "Hub and

Spoke" holistic model is, possibly referring to the one-door concept. She asked if anyone knew what "platform growth" means.

- Mr. Hughes thinks it means growth from where you are at.
- Mr. Thomas said he thinks the platform is to end homelessness and to escalate that and raise awareness to improve on the accomplishments that have already occurred.
 - Ms. Boies asked if the membership list is similar to the previous Task Forces.
 - Mr. Hughes said yes.
- Ms. Sanchez said they have representation from all of these agencies and they will be visiting with Hank Hughes to come up with the key funders.
 - Mr. Hughes mentioned that they had a pretty big list of people they wanted to invite.
 - Chair Montoya-Gansel asked how many people they are talking about.
 - Ms. Sanchez said about 50 people.
 - Mr. Hughes said this is why they need a facilitator.
- Ms. Sanchez said the only things she has to report back is to define what a "Hub and Spoke" holistic model is and have a description of what it means, possibly adding attachments of other models of what this looks like. The other thing is to explain what platform growth is; and add in the end homelessness platform documents/reports from 2017 and 2012.
- Ms. Boies asked if all the 50 people will be appointed by the Mayor the Resolution only talks about the Mayor designating the Chairperson but it does not state that all the members have to go through the Mayoral Appointment process.
- Ms. Sanchez said no, because it is a task force, they do not have to go through the entire committee process, like they do for other committees.
 - Chair Montoya-Gansel asked if there is anything else that they would like to add.
- Mr. Hughes said no, he thanked everyone for being here today. He asked Ms. Sanchez what the next step would be given that they did not have a quorum today.
- Ms. Sanchez said it will still go before the Finance Committee next Monday and to City Council the following Wednesday. Then they will move forward with getting the first meeting scheduled, probably sometime in March.
 - Chair Montoya-Gansel asked if anything came out of the two previous task forces.
 - Ms. Sanchez said she met with Hank Hughes, Chris Sanchez and the Mayor and there

were a lot of good things that came out of that meeting and one of them was the Interfaith Shelter – that came out of the 2007 End Homelessness Plan and the focus in 2012 was on veterans and veteran homelessness, and this is one of the reasons why the Veteran's Board was created- to fund towards veterans' homelessness. They also expanded housing for homeless individuals at Casa Familia.

She said this will be kind of an update, taking all those things into consideration moving forward on how to address these new issues coming up with the opiates, with mental health issues; and is there more funding that needs to be funneled towards these triage services, etc.

Ms. Boies said it would be good to add a sentence on what the two previous task forces did. For example, the first Task Force established or created the Interfaith Community Shelter, which initially was going to be called the Resource Opportunity Center.

b. Discuss and Recommend Approval: HSC 2018 Priority Indicators

[Copies of the handout: *Human Services Commission Priority Indicators -Ends Framework* were distributed. A copy is hereby incorporated to these Minutes as Exhibit "4b".]

The table outlines county level priority indicators selected by the Commission in 201 and their comparison to the State of New Mexico and the US, where available. Some indicators do not have reliable or available data sources.

Ms. Sanchez said she would like to discuss the HSC 2018 Priority Indicators and get the Committee's feedback on them. She said the Committee had tasked Aspen Solutions to come up with some indicators and baselines and then HSC was going to go through them, provide feedback and choose some priority areas that they would focus on for funding next year.

She said the funding for this Committee reopens again next February and they want to do a strategic planning session sometime in September. They would like to completely solidify the evaluation process and a new funding matrix.

Ms. Sanchez said the priority indicators are what Arianna Trott and Natalie Skogerboe of Aspen Solutions found when looking through local Santa Fe County data and national data. They compared them to see where we rank in some areas on where the City might want to focus on for next year's funding cycle.

Ms. Boies mentioned that the County has their own Action Plan and it contains a report card, which shows where the County is. She noted that some of the HSC priority indicators are the same or coincide with Santa Fe County's list. She briefly reviewed and compared the County's priority indicators with the HSC priority indicators.

She asked Ms. Sanchez if the point today, or when the Committee has a quorum, is to confirm that these priority indicators would be the right ones to be looking at.

Ms. Sanchez said yes, and possibly even scaling down some of these. She said all of these are important, but the question is what should the Committee be focusing on in terms of funding next year. She said the Committee could vote on these now and then in September, solidify them as priority indicators.

Ms. Trott referred to the back page of the priority indicators noting that a section was created for data development agendas that need to be put in place on some of the indicators-to look for different ways to measure data.

Mr. Serna said the Committee could use this as a guide but it is obvious to him that they need to put some funding towards behavioral health issues, just in general. He said some of these things are tied together like Alcohol-Related deaths and Drug-Related deaths. If we make improvements in one, hopefully we'll make improvements in both. He would like to see some things pulled apart with the alcohol-related and drug-related deaths to see how much of those are alcohol-involved auto accidents versus chronic disease types of death.

Ms. Boies said in regards to Alcohol-Related deaths, the County Community Services Department has a DWI Division and they met with the Santa Fe Community Foundation and are talking with them about developing a DWI report card. She said she could find out a little more about what the indicators are - that Mr. Serna is referring to.

Ms. Sanchez said once the Committee selects the indicators, Aspen Solutions will also look at race, gender and income level so that they can also have a targeted approach on who funding should really go to, making sure they have priority populations or areas within these indicators that they want to target.

Chair Montoya-Gansel said she is wondering if they are really doing okay with food security because she knows that the demand (for food resources) continues to grow.

Ms. Boies said the County's Gap Analysis was recently completed and the four things that emerged were: housing; behavioral health; senior services and taking care of seniors; and coordination among agencies and navigation.

There was discussion about the lack of (short-term) rental housing assistance, such as paying utilities when a tenant falls behind, or paying the rent so that the tenant does not get evicted, etc.

Ms. Boies explained that the County has set aside a "Flex Account" for their service providers and it is used for one-time expenses that will make a difference in their client's life. It could be paying for a security deposit, or a bus pass, things that do not continue on and on because they don't have funding to do this. She likes the idea of having this Committee looking at agencies who can help with those bigger things that make a difference. She did not know how this fits in the indicators but thinks this would be a good focus for the Committee and she thinks it would good for the Committee to do something around housing.

Ms. Sanchez noted that United Way used to offer emergency assistance for rental evictions, utilities, up to a certain amount of money. She mentioned that the Children and Youth Commission created a side fund and they called it the "Innovation Fund". This is for non-profits in the community to apply for monies for programming or things that don't necessarily warrant getting a \$15,000 grant from that Commission. These would be smaller grants that could help with either starting a new program or project, or benefiting the community that they are serving.

Ms. Sanchez said this will be something that will be brought up at the HSC Strategic Planning meeting-maybe exploring the idea of having a similar flex fund within the grants that the HSC gives.

Chair Montoya-Gansel said when putting out the RFP, the Committee could say that they are looking for an agency who could offer rental or eviction assistance. She said maybe there is already an agency who is doing this but the Committee does not know about it.

Ms. Sanchez mentioned that the Veteran's Advisory Board contracted with the Veteran's Integration Center to do emergency services. They granted them a \$20,000-\$30,000 grant to administer to veterans in the City of Santa Fe to get them (three priority areas): housing; healthcare and employment.

She said the HSC could try a pilot program to do something like this, for emergency-type services.

Ms. Sanchez asked if there was anything else with the indicators or if there were any that the Committee would like to strike out or discuss.

Ms. Boies said she is struck by, and again, these are averages, to see how much better the County is doing compared to both New Mexico and the US, in terms of obesity among adults. She said there is quite a difference, and same with diabetes.

Ms. Sanchez said the only one that she could see that the HSC may want to strike out is the "mental health providers".

Mr. Serna and Ms. Boies questioned the ratio and said this does not really match what they are trying to measure and does not tell the Committee much.

Ms. Sanchez said they really could not find this data and the Committee should keep in mind how they will fund this indicator.

Ms. Boies said of all the data development agendas that need to be put in place, the most important one to her is the intimate partner violence indicator.

Ms. Trott noted that they have state and national prevalence from one source and from another source and these sources do not measure/ask the same thing.

Chair Montoya-Gansel provided information to Ms. Trott on an organization in

Albuquerque who collects data for this.

Ms. Trott thanked the Committee for their feedback.

c. Discuss and Recommend Approval: 2018 HSC Grantee Site Visit Calendar

Ms. Sanchez said the Committee does not have a quorum to approve the 2018 HSC Grantee Site Visit Calendar but she wanted to get it approved so that she could send it to the grantees and give them time to fill out the site visit forms. The Committee briefly reviewed the site visit calendar and Ms. Sanchez will make some minor amendments to it.

d. Discuss and Recommend Approval: 2018 HSC Budget This agenda item was not discussed.

Lindell 7 8 9 10 A RESOLUTION 11 ESTABLISHING A HOMELESSNESS TASK FORCE TO ANALYZE, PLAN AND 12 DESIGN A LONG TERM INTEGRATED SOLUTION FOR PEOPLE WHO ARE 13 HOMELESS IN THE CITY OF SANTA FE AND PROVIDE RECOMMENDATIONS TO 14 THE GOVERNING BODY. 15 16 WHEREAS, the United States Interagency Council on Homelessness defines an end to 17 homelessness as every community having a systematic response in place that ensures 18 homelessness is prevented whenever possible; and 19 WHEREAS, planning and implementing an optimized homeless crisis response system 20 that assures homelessness is rare, brief and non-recurring for people in the City of Santa Fe; and 21 WHEREAS, the City of Santa Fe is committed to providing affordable housing 22 opportunities for all of its residents; and 23 WHEREAS, in late 2016 the United States Interagency on Homelessness, Department of 24 Housing and urban Development, and Department of Veterans Affairs confirmed that the City of

Santa Fe had effectively ended homelessness among veterans; and

WHEREAS, the City of Santa Fe achieved this result by working with a broad coalition
of partners that included the City of Santa Fe Affordable Housing and Community Services
Department, the Veterans Advisory Board, the New Mexico Coalition to End Homelessness, the
Department of Veterans Affairs, Lifelink, Goodwill, Healthcare for the Homeless, the Interfaith
Community Shelter, St. Elizabeth's Shelter, the New Mexico Veterans Integration Center, and the
Housing Trust; and

WHEREAS, homelessness continues to exist among the general population in Santa Fe;

WHEREAS, the City of Santa Fe deems it necessary to identify the gaps in service and funding that exist among the various providers in the city, and provide recommendations for wraparound services that would advance the effort to combat and eliminate homelessness; and

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF SANTA FE that the mayor will appoint, with the approval of the Governing Body,

To convene a group of professionals within the homelessness profession to strategically analyze the following and provide recommendations to the City of Santa Fe in an effort to make homelessness rare, brief and non-recurring:

- 1. Service providers and their current capacity;
- 2. Housing needs and gaps (shelters, transitional housing, rapid rehousing and
- Service and program needs and gaps;
- 5. Care and referral mapping (Integrated Service approach);
- 6. Funding; and

7. Assessment of partnerships and collaborations.

1	DUTIES AND RESPONSIBILITIES: The task force shall consider and develop a strategic
2	road map that outlines the purpose above and works from a "Hub and Spoke" holistic model to
3	provide stability and platform growth from being homeless to independence for our homeless
4	population throughout Santa Fe.
5	MEMBERSHIP; OFFICERS; TERMS: The task force shall consist of representatives from
6	homeless shelters, judicial and law enforcement agencies, the City of Santa Fe, Santa Fe County,
7	affordable housing providers, and key funders towards combatting homelessness. The Mayor
8	shall designate the chairperson; the vice chairperson shall be designated by the chairperson. The
9	members shall serve until they complete their duties and responsibilities as set forth above.
10	Members shall serve without compensation.
11	VACANCIES: Vacancies on the Homelessness Task Force shall be filled in the same manner as
12	initial appointments.
13	MEETINGS; DURATION: The Homelessness Task Force will hold monthly meetings with
14	any subcommittees meeting monthly to research, discuss, evaluate and provide recommendations
15	or an overall report on designated items. The Task Force shall report to the Governing Body
16	within 6 months of adoption of this resolution.
17	STAFF LIAISON: The Youth and Family Services Division for the City of Santa Fe shall
18	designate a staff liaison for the Task Force.

Once we establish these priority indicators, we can try to drill down further to look at the disparities that might exist by zip code or neighborhood in the city, and do historical trends for our local level indicators.

Data development agendas need to be put in place for the following indicators:

- Untreated adults with mental illness: We have state and national prevalence, and this issue seems to be at the heart of the City and County's vision, so we will research methods for gathering these data at the local level.
- Intimate partner violence: We have state and national prevalence from one source (2010-2012, National Intimate Partner and Sexual Violence Survey, cdc.gov/violenceprevention) and county level prevalence from another source (2007, Survey of Violence Victimization, ibis.health.nm.us). These sources do not ask/measure the same thing.
- DACA applications: Conversations with Santa Fe Dreamers reveal a need for deeper study of successes among DACA recipients. Aspen Solutions would like to develop a method for collecting outcomes within that cohort (education, employment, housing, sense of community, etc)
- Abuse and neglect among vulnerable adults: Data requests have been sent to ALTSD and CYFD but we are still working on these data. We believe we will be able to get state and county rates or prevalence but not sure how that will translate to national data sets.
- Veteran employment and/or benefit usage: New Mexico Workforce Solutions published reports on Veteran employment participation and unemployment. We can work with them to access county level data.
