11 NAMING FIELD #3 AT RAGLE PARK AFTER COACH PETER E. HERRERA.

13 WHEREAS, resolution 2010-19 permits city-owned parks to be named after community  
14 members who meet certain criteria; and

15 WHEREAS, those criteria include:

- 16 1. the individual must be deceased;
- 17 2. the individual must have made significant contributions to the community;
- 18 3. the individual must have been of high integrity and good moral character;
- 19 4. the individual must have been a resident of Santa Fe county or have a strong  
20 connection to Northern New Mexico;
- 21 5. the individual may have made charitable contributions of time or money either in the  
22 past or in the present; and

23 WHEREAS, the Governing Body desires to name Field #3 at Ragle Park after Coach Peter  
24 E. Herrera; and

25 WHEREAS, Coach Peter E. Herrera was a pillar in the community of Santa Fe, coaching

1 many of Santa Fe's youth in both basketball and baseball for many years; and

2       **WHEREAS**, Coach Peter E. Herrera was a role model and mentor to many youth in our  
3 community; and

4       **WHEREAS**, Coach Peter E. Herrera was a friend to many and was always there to make  
5 people laugh with his contagious personality; and

6       **WHEREAS**, Coach Peter E. Herrera gave his undivided attention to the youth of Santa Fe in  
7 order to insure that they had a coach who had the passion and vision to insure that those he coached  
8 learned and enjoyed the game they played; and

9       **WHEREAS**, Coach Peter E. Herrera spent many days and nights at Ragle Park coaching, and  
10 mentoring many teams and players in the AABC (American Amateur Baseball Congress). It is fitting  
11 that this honor be bestowed upon him at this park.

12       **NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE**  
13 **CITY OF SANTA FE** that Field #3 at Ragle Park is hereby renamed Coach Peter E. Herrera Field in  
14 recognition of the service Coach Peter E. Herrera provided to the residents of the city of Santa Fe  
15 through his work mentoring and coaching countless youth in our community.






