CITY OF SANTA FE, NEW MEXICO ORDINANCE NO. 2018-10

AN ORDINANCE

AMENDING THE OFFICIAL ZONING MAP OF THE CITY OF SANTA FE; CHANGING THE ZONING CLASSIFICATION FROM R-5 (RESIDENTIAL-FIVE DWELLING UNITS PER ACRE) TO C-1 (OFFICE AND RELATED COMMERCIAL) FOR THE AREA COMPRISING APPROXIMATELY 0.34 ACRES LOCATED NORTH OF 1773-1787 HOPEWELL STREET WITHIN T17N, R9E, PROJECTED SECTION 34 N.M.P.M., SANTA FE COUNTY NEW MEXICO); AND PROVIDING AN EFFECTIVE DATE. (HOPEWELL MANN REZONING, CASE NO. 2017-134).

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF SANTA FE:

Section 1. That following real property (the Property) located within the municipal boundaries of the City of Santa Fe, which has been restricted to and classified as R-5 (Residential - Five (5) Dwelling Units per Acre), is hereby restricted to and reclassified as C-1 (Office and Related Commercial):

A portion of land comprising approximately 0.34 acres located within the Hopewell Mann Lease Tract, as described in the warranty deed from Bess G. Thomas to the City of Santa Fe, Instrument No. 261/840, and referenced as a portion of a parcel of approximately 5.83 acres at Hopewell Street and Quapaw Place, "portion of Zimmerman's Tract No.236" and recorded in the office of the County Clerk of Santa Fe County New Mexico on December 31, 1962, as described in Exhibit A attached hereto and incorporated herein by reference. This portion of land lies on the north side of the arroyo running east to west across the

1	northern part of the Hopewell Mann Lease Tract.
2	Section 2. The official zoning map of the City of Santa Fe adopted by Ordinance
3	No. 2001-27 is hereby amended to conform to the changes in zoning classifications for the
4	Property set forth in Section 1 of this Ordinance.
5	Section 3. This Ordinance shall be published one time by title and general summary
6	and shall become effective five days after publication.
