13	ELECTED IN 2018 WILL END DECEMBER 31, 2021; AND ESTABLISHING A NEW
14	SUBSECTION 9-1.19 TO CREATE EFFECTIVE DATE CONTINGENT UPON THE
15	VOTERS' APPROVAL OF SANTA FE MUNICIPAL CHARTER AMENDMENTS AT THE

18	BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF SANTA FE:
19	Section 1. Subsection 9-1.2 SFCC 1987 (being Ord. No. 2011-28, § 1) is amended to
20	read:
21	9-1.2 Local Election Act opt-in; Conduct of elections.
22	The city of Santa Fe opts-in to the Local Election Act. Municipal elections in the city shall be
23	conducted in accordance with the Santa Fe Election Code, the Santa Fe Municipal Charter and the
24	New Mexico Local Election Act. The date of the regular municipal election shall be the first Tuesday
25	in November of odd-numbered years.

2 9-1.18 [<u>NEW MATERIAL</u>] Transition. The terms of the city councilors and municipal 3 judge whose terms were set to expire six days after the March 2020 regular municipal election shall 4 expire on December 31, 2019. The terms of the mayor and city councilors whose terms were set to expire 5 six days after the March 2022 regular municipal election shall expire on December 31, 2021. 6 Section 3. A new Subsection 9-1.19 SFCC 1987 is ordained to read: 7 9-1.19 [NEW MATERIAL] Effective Date and Filing Date. The amended provisions 8 regarding the New Mexico Local Election Act in Sections 9-1.2 and 9-1.18 SFCC 1987 shall be 9 effective provided that a simple majority of the qualified electors of the city of Santa Fe vote in favor 10 of the 2018 Santa Fe Municipal Charter amendment question and the proper canvassing board certifies 11 the results. If the 2018 Santa Fe Municipal Charter amendment question is approved by voters, the city 12 clerk shall file a copy of this ordinance with the New Mexico Secretary of State no later than January 13 30, 2019. 14 PASSED, APPROVED AND ADOPTED this 10th day of October, 2018. 15 16 17 ATTEST: ALAN M.
