7	National Cemetery Fund, for veteran programs, pursuant to City of Santa Fe Resolution No
8	2013-2, including promoting and educating taxpayers about the option to voluntarily contribute to
9	the Fund on NMPIT-1 New Mexico Personal Income Tax Form, line 40.
