10 **A RESOLUTION**

11 **SUPPORTING FEDERAL LEGISLATION TO DESIGNATE BANDELIER NATIONAL**  
12 **MONUMENT AS A NATIONAL PARK AND PRESERVE.**

13  
14 **WHEREAS**, located in north-central New Mexico, Bandelier National Monument  
15 encompasses an array of archeological, historic, and natural features; and

16 **WHEREAS**, its main attraction, Frijoles Canyon, where there are ancient dwellings and  
17 petroglyphs, is a popular destination among American travelers; and

18 **WHEREAS**, Bandelier National Monument was named a National Monument in 1916  
19 by President Woodrow Wilson; and

20 **WHEREAS**, in 1986, the monument included a designated wilderness area of 23,267  
21 acres among its 32,737-acre total area, an area that will be designated a preserve to restore the  
22 scenic, educational, cultural, and historical value of the area; and

23 **WHEREAS**, Senator Martin Heinrich has introduced the Bandelier National Park and  
24 Preserve Establishment Act (“Act”) that would elevate Bandelier Monument to a National Park  
25 and designate the wilderness area as a National Preserve; and

1           **WHEREAS**, if the Act is enacted, sport hunting would be permitted within the National  
2 Preserve, as well as the collection of plants for traditional tribal uses; and

3           **WHEREAS**, if the Act is enacted, the Tribal Advisory Commission would be required to  
4 provide guidance and recommendation on the development and implementation of management  
5 plans; and

6           **WHEREAS**, New Mexico currently has one National Park, Carlsbad Caverns, located in  
7 southern New Mexico, and elevating Bandelier National Monument and Preserve would provide  
8 an economic boost to, and raise the profile of, the State of New Mexico.

9           **NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE**  
10 **CITY OF SANTA FE** that the Governing Body urges Congress to adopt the Act or other  
11 legislation designating Bandelier National Park and Preserve as the second National Park in New  
12 Mexico.


13           **BE IT FURTHER RESOLVED** that copies of this resolution be transmitted to the New
