18	issue bonds for financing of public projects for benefit of the Governmental Unit; and
19	WHEREAS, the New Mexico Finance Authority (the "Authority") has instituted a
20	program for financing of projects from the public project revolving fund created under the Act
21	and has developed an application procedure whereby the Governing Body may submit an
22	application (an "Application") for financial assistance from the Authority for public projects; and
23	WHEREAS, the Governing Body has undertaken a plan to refund, refinance, and
24	defease the Governmental Unit's Taxable Subordinate Lien Gross Receipts Tax Revenue Bonds,
25	Series 2009 (PPRF-2328) for the benefit of the Governmental Unit and its residents (the

12	Section 3. That the City Manager is hereby directed and requested to work with City
13	staff to submit the completed Application to the Authority for its review, are further authorized to
14	take such other action as may be requested by the Authority in its consideration and review of the
15	Application, and shall further proceed with arrangements for financing the Project.
16	Section 4. All acts and resolutions in conflict with this resolution are hereby rescinded,
17	annulled, and repealed.
18	Section 5. This resolution shall take effect immediately upon its adoption.
