3	Legislature to purchase rights-of-way and to plan, design, and construct road improvements at the
4	intersection of Agua Fria Street and South Meadows Road; and
5	WHEREAS, the intersection of Agua Fria/South Meadows is experiencing delays
6	associated with ongoing and future development in the area.
7	NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE
8	CITY OF SANTA FE that the Governing Body accepts the NMDOT grant for C5193408 Project
9	funding.
