1. CALL TO ORDER

The meeting of the Mayors Committee on Disability was called to order by Aurore Bleck, Chair at 10:00 am, on Thursday, June 20, 2019, at the City Council Chambers, 200 Lincoln Avenue, Santa Fe, New Mexico.

2. ROLL CALL

3. APPROVAL OF AGENDA

Ms. Gish added an item 8C for a SNAP update.

MOTION A motion was made by Mr. Wirtz, seconded by Ms. Gish, to approve the agenda as amended.

VOTE The motion passed unanimously by voice vote.

4. APPROVAL OF MINUTES MAY 16, 2019

Ms. Reed said on page 8, the bottom, 3rd line it should say she has found out.

Mr. Wirtz said on page 5,7 and 9 his name is misspelled.

Ms. Gish said on page 1 her name is misspelled.

Chair Bleck said on page 5, the first paragraph, it should say hearing devices since; it should say 70%, on page 9, under Transit, the first paragraph, it should say redoing the Sheridan Downtown Bus Stop, in the next paragraph it should say 4 new buses, in the next line it should be Route Match Program, which should increase efficiency; in the next paragraph, second line, it should say Santa Fe Pick Up and entity; on page 10 it looks like a line was dropped and under Items From Members and Staff it should say Ms. Parfitt.

MOTION A motion was made by Mr. Wirtz, seconded by Ms. Reed, to approve the minutes as amended.

VOTE The motion passed unanimously by voice vote.

5. PUBLIC COMMENTS

Mr. Garcia, a member of the public, said he has Comcast and is able to watch the Council meetings from home, but others have Dish or Direct TV and cannot see the meeting.

The IT Department verified that the City's franchise agreement is with Comcast only and that is the only service that provides access to the City Council meetings.

6. PRESENTATIONS

A. COMMUNITY SERVICES DIRECTOR KYRA OCHOA MOVING FORWARD PRESENTATION

Ms. Ochoa said thank you for having her today so that she can tell you more about the Community Services Department and take questions on how they may overlap with your concerns.

Ms. Ochoa reviewed a power point presentation which is herewith attached to these minutes as *Exhibit "1*".

Ms. Ochoa spoke additionally about her ideas for the consolidation of committees. Each group has distinct and unique agendas, however; when you look at overall issues there are ways we can come together to advocate for what we need to address the issues. She is working on forming a Community Health Council. It will have a delegate from every Board and Commission, such as a member from the Veteran Board, Youth Commission Senior Board etc. We would love to have a member of your Committee sit on it as well.

Chair Bleck said we would love to.

Ms. Ochoa said our goal is to make sure we are addressing health planning and that we represent all of these groups needs. How do we allow the committees to have more public engagement is something we have been thinking about. Is some of the work being done something that could be done at a strategic level. Then you might be freed up to work out there and give ideas to the Health Policy Council and the Health Policy Council will become the Advisory Group to the City Council. Maybe they could vet and recommend the policies and forward them to the Council.

Ms. Jawhar asked have you connected with the Santa Fe Prevention Alliance.

Ms. Ochoa said yes, we are all connected to them. We do not fund it. They are City and County funded. There are many more organizations we work with. It would be nice not to have to fund people to be partners with them. If referrals come up with this organization we will invite them to participate.

Ms. Jawhar asked what do you think about collaborating with the MCOs. They are all involved with re-entry from jail. She is with Blue Cross Blue Shield.

Ms. Ochoa said MCOs are key to this. We are in conversations with the Human Services Department to forge communication and collaboration. The other element is the funding. Some of the work funded at the MCO level might be properly funded at a local level. Some of them do great work, but they need accountability and to formalize connections. It has to happen at the level of HSD who funds MCOs. A lot of entities want to own the data.

Ms. Jawhar said exactly, we need one place and portal.

Mr. Wirtz said one of your Boards deals with immigrants. Trump is saying we are going to round them up and send them home. Is this Department working to help alleviate the concerns Santa Feans have for these folks.

Ms. Ochoa said yes. The Immigration Committee is very concerned about the issue. We are working with advocates and nonprofits for these folks. The recent influx of asylum seekers into New Mexico is underscoring the need. We are seeing increased pressure on businesses who employ residents who are not legal. The Immigration Committee is doing education with the businesses. You have to comply with the law, but can do it a certain way for families. We are not advocating at a Federal level. The Immigration Committee does advocate for policy and look at that issue.

Ms. Reed asked as to housing, do you work with the Santa Fe Civic Housing Authority and the new housing developments to have low income units and do you work with getting those units filled.

Ms. Ochoa said the City has an Affordable Housing Department. We do work in collaboration with that Department and Alexandra Ladd. We have as a City and Department joined a national initiative called Built for Zero which attempts to end chronic and Veteran homelessness across the country. We need to look at who is precariously housed, case management, prioritize and put people where they need to be. We need to work on those things. Can we target and get a funding source to work with that. The navigation Network does work individually with folks.

Ms. Reed asked can that be incorporated into other communities.

Ms. Ochoa said yes. We can find housing more easily in Espanola for instance. We work closely with the Coalition to End Homelessness. We are getting technical assistance on how to do this better and increase the amount of street outreach we have. Many people do not want to go to services. It is more effective to go to them.

Ms. Reed said that is great to know. When she worked with the Governor's Commission disabled people would call with issues about their housing situation. Your agency has a more broader initiative.

Ms. Ochoa said yes. We work with both shelters and other housing services. Getting a rapid response is important.

Ms. Jawhar said all of the agencies you mentioned with regard to housing are all stretched. She finds people with extreme behavioral health issues are still homeless or couch surfing. All of these tools are in place, but the end result is really slow and few and far between.

Mr. Ochoa said yes. That is undeniable. When you get a system to get a scope of the need and you couple that with technical expertise around creating housing stock in the community, like landlord education that is an initiative we could do together such as education for Section 8 landlords. In terms of building units and supportive housing units and mixed income units there are some very interesting funding mechanisms we are learning about such as if we could find a hotel we could convert into single room occupancy in Santa Fe and populate it with mixed income and a large amount of Veterans and low income folks and not ghettoize it, it would be a wonderful place to live for all of them. We are looking at ways to do this. Other communities have done this. There are some funding opportunities out there.

Mr. Jawhar said she would like to be kept in the loop on that. Thank you so much.

Ms. Gish said regarding Section 8 housing there is a problem in Santa Fe of landlords discriminating. My mom was on the waiting list for 2 years and went from 32 to 28. It is a three and a half year wait list. The City Council in LA passed an anti-discrimination law that no landlords can discriminate against Section 8 applicants. The same thing happened in Seattle. She does not know if that is even possible in the City of Santa Fe, but there needs to be awareness.

Ms. Ochoa said that needs advocacy across the board. That is precisely the type of policy recommendation she sees feeding to the Policy Council and on to the Governing Body. That is the mechanics. You are the mechanism.

Chair Bleck said we do need to be a part of the Council. We are so glad you came today. Thank you.

Mr. Chapman said he can extend an invitation to the Affordable Housing Director and see if she could attend our next meeting.

Chair Bleck said that would be good.

Mr. Chapman said thank you very much Kyra.

7. NEW BUSINESS - DISCUSSION AND POSSIBLE ACTION

A. SAMS CLUB ACCESSIBILITY CONCERNS

Chair Bleck said we had a complaint from someone who did not have much energy and tried to go to Sams Club and needed help and was not getting it. They eventually got help from the Manager. The front line employees were clueless. Another complaint we got about Sams Club was that the handicapped spaces are not big enough.

Mr. Chapman said the fact that Sams Club was permitted leads him to believe that the parking is within the guidelines of ADA. One point that came to mind is that they did the bare minimum to be in compliance.

Chair Bleck said we are trying to raise their consciousness.

Mr. Chapman said yes. Improvements that ADA requires help not just people with disabilities, they help everybody.

Chair Bleck said in this particular instance the person would have been helped if the front line employee had been more flexible and had training about awareness and sensitivity. We talked about revising our brochures and maybe have a brochure for businesses offering them some guidelines. The City ADA Coordinator could work in conjunction with us and the Health Council on housing issues, training and offer some half hour training to businesses.

Mr. Chapman said on the existing brochure he would like to give that to Kyra and ask her to add the organizations she may know of that should be on the list.

Chair Bleck said she agrees. We need major revisions of our brochures..

Ms. Gish said they also need to be updated on line.

Chair Bleck said we need to do that. We can all start thinking about things we could do to update that and have in training sessions. If anyone has ideas shoot them out to her.

Mr. Chapman said the City has a dedicated channel. Maybe the Committee could think of a one minute presentation on awareness to put on there. A public service announcement. Dr. Maynard used to do those kind of things.

Chair Bleck said there was an article on the Housing Trust in the Santa Fe Reporter. One of the problems noted was the landlord/tenant relationship.

Ms. Jawhar asked how would we propose to have training sessions and advertise that out to the general public.

Ms. Reed said NMFA has training every other year.

Chair Bleck said we need to think about what would need to be in a training.

Mr. Hughes said as an alternative to training for Section 8 housing it might be more effective to treat that as a marketing issue. Kyra brought up her perception of the value of having Section 8 renters. The disconnect is between landlords and the quality of tenant they get. Instead try to change their perception of Section 8 tenants.

Ms. Jawhar said do a training on that as well. We need them to rent to our people.

Ms. Gish said there are many websites that have those details, but the City of Santa Fe does not. We could get them to update that and make it friendly for landlords to use.

Mr. Hughes said one thing that would be helpful to highlight would be success stories like Kyra's.

B. LOOP SYSTEM ACCESS AT CITY FACILITIES

Chair Bleck said Pam is not here because she is attending a hearing loss convention. She prepared a draft letter for us to discuss. It is included in your packet. What are your thoughts of the letter.

Everyone wanted to send it.

A. MCD SUBCOMMITTEE REPORTS

PLAN REVIEW

Ms. Reed reported that they have had no plans to review. We did not get anything on the Sheridan Bus Station.

Mr. Chapman said he will follow up on that. He does have some plans coming for the subcommittee.

Mr. Hughes said he thinks Kyra and her Department are doing a lot of work that our Committee was looking at such as taking a more holistic approach around trauma and healthcare and helping to provide individual services and assessing the return on investment. He thinks the way we can be more effective is simply by coordinating with them and continue to offer our expertise.

<u>IPM</u>

Mr. Wirth said he is glad to have Victor Lucero rehired for IPM.

TRANSIT

Chair Bleck reported that they are about to get four new para transit vans and are hoping to get the Transportation Center underway this fall and finished by November. They continue to have issues with the Sheridan Bus Station. They are fully staffed in para transit.

Ms. Jawhar left the meeting.

Chair Bleck said our transit ridership numbers are dropping. Only four cities in the nation have added riders. Para transit ridership is up. Transit has improved their time performance percentage.

B. ADA COORDINATOR HIRING STATUS

Mr. Chapman said the City has selected Tom Graham as the new ADA Coordinator. He currently works for the Governor's Committee. He has accepted the position. The paperwork is still moving through HR. We are expecting him to be on Board in the latter part of July.

C. SNAP UPDATE

Mayor's Committee on Disability

Ms. Gish said we found the State law that coincides with the Federal law stating that SNAP cannot be counted as income.

Mr. Chapman said he will draft a letter to the City Attorney's Office. Ms. Wheeler is on board with this. She said to go ahead and get it done.

9. ITEMS FROM MEMBERS AND STAFF

Ms. Montoya-Chavez said she would like to see first responders get an awareness program going saying attention needs to be given to special needs people in vehicles and houses in the event of emergency. We need some sort of identification sticker on the car and home windows. She got in an accident over a year ago and her son, who is non-verbal, was in the car with her. The officer kept asking him what his name was over and over. It is critical for children.

It was suggested that she speak to Councilor Rivera who is the Chair of the Public Safety Committee.

Chair Bleck said she has something like a packet on her front door for identification.

Mr. Wirtz said he has a sticker on his sliding glass door and there are bracelets.

Mr. Hughes said there is a mobile application that allows first responders to be aware of the needs of the public they interact with.

Ms. Gish said ongoing training is greatly needed.

Ms. Montoya-Chavez will also check with Councilor Rivera.

Chair Bleck asked Ms. Montoya-Chavez to keep the Committee posted.

- 143 year-round employees and 93 summer employees provide services to approximately 12,500 residents of Santa Fe and surrounding areas, not including non-cardholding visitors to our libraries, who number in the tens of thousands.
- Through our partnerships with community-based organizations, we indirectly serve over 50,000 pregnant women, young children and families, and adults of all ages with behavioral health, educational, and safety net services.
- We staff 5 committees, 4 boards, and 2 task forces, engaging over 50 volunteer appointed members in impacting services and policies in the wider community, including youth, immigrants, veterans, and seniors.
