a. Public Art Policies and Procedures Draft Document

Collections Management Policy

All commissioners have been asked to review and to bring edits to the table tonight and Ms. Hanley will make the changes. The document would go to the Director, Legal

Department and back to the Commission. Thank you to the commissioners who were instrumental in doing this review.

Question: Is this document going back to the Arts Commission? Question: Will this procedures document go to City Council?

Ms. Kamiyama: It would not as it is a policy or procedure.

Ms. Hanley said that we should have a document that is distinct, there are a lot of things that need to be visited from the City level. Example; we are not permitting, and we do not want to make murals in the city more challenging. Information is good, we should create best practices for painting a mural, all the specific information should not come to this committee for review.

The Acting Chair asked, do we decide on some of the newer initiatives?

Pauline Kamiyama: Historic Preservation and District – they are looking at updating their mural code. As the new Arts and Culture Department that is not in our purview, that will go to Land Use. Public Art requests do fall under Arts and Culture Department.

Mr. Lambert said that would also be standardized in the RFP. Ms. Hanley said they did extract some information that was outdated. What she is hearing is what is the role of the commissioners? Example the mural discussion.

Mr. Bernal: There was a question last night regarding a mural that was being done with no supervision, is there a procedure for repair?

Mr. Lambert said that there use to be a procedure in the past and the building had to be stucco. Staff noted that there were a lot of complaints, but nothing had been done. It was a mural over by Finance and was very old.

Mr. Bernal: Is there any guidance?

Ms. Kamiyama: There is no mural process for the city. If there was a request it would come to Art in Public Places, and we would review. The definition of a mural and a sign has now become very contentious. There are now questions and litigation related to a national piece.

Ms. Hanley: 1st amendment - if it was on a public building. Document: some of the language she got from the web and some from staff.

Drew Lenihan: Calling something a cultural --- a collection is a collection – I don't see any extractive language. Artifacts is a word I can do without. Cultural Resource is something to consider.

Community Narrative Definition: information from the city and other places.

Document needs to be page numbered.

Draft Collections Document: Not to be distributed.

Drew Lenihan: Abstract to aesthetic.

Ms. Kamiyama: Look at how to define narrative.

Ms. Hanley noted that it has been included.

The Donor must transfer the unconditional title of all objects donate to the City. The Donor will understand that the city holds the right to deaccession an object if conditions deemed necessary in the future. *David Scheinbaum: This provides the city with more options.*

Objects shall not be accessioned into the City's Permanent Collections unless the City can provide for the storage, protection, and preservation of the objects under conditions that ensure their physical integrity and availability in keeping with the AAM Code of Ethics. NOTE: We would create our own. Jorge Bernal: Alliance of American Museum has strong language.

PERMANENT COLLECTIONS – OBJECTS FOUND IN THE COLLECTIONS (OFIC) What defines Public Art Collection? Define gifted items?

MURAL GUIDELINES (in accordance with the City of Santa Fe Ordinance) COMMERCIAL BUILDING MURAL PROGRAM GUIDELINES

Brochure Guidelines? Provide guidelines as opposed to rules, we don't want to over administrate it. Historical design, if it applies. Anticipate options for the future, may not be happening with the city right now. Think of the "what if's" that are good.
