14	WHEREAS, Resolution No. 2010-19 permits City-owned parks to be named after
15	community members when certain criteria are met; and
16	WHEREAS, those criteria include:
17	1. the individual must be deceased;
18	2. the individual must have made significant contributions to the community;
19	3. the individual must have been of high integrity and good moral character;
20	4. the individual must have been a resident of Santa Fe county or have a strong
21	connection to Northern New Mexico; and
22	5. the individual may have made charitable contributions of time or money either in the
23	past or in the present; and
24	WHEREAS, the Governing Body desires to name the park in the Vistas Bonitas subdivision
25	after Bill and Dusty Dawson; and

1	WHEREAS, Bill and Dusty moved to New Mexico in 1960 and eventually opened The
2	Green Onion in 1973, employing 30-35 people; and
3	WHEREAS, Bill and Dusty started the community celebration of St. Patrick's Day, even
4	receiving a proclamation in 1986 proclaiming March 17th "Mr. Irish Himself – Bill Dawson Day";
5	and
6	WHEREAS, the proclamation, signed by former Mayor Sam Pick, states that "Bill Dawson
7	has demonstrated his love for our City in many ways"; and
8	WHEREAS, Bill and Dusty donated funds for the creation of Salvador Perez Park; and
9	WHEREAS, Bill's and Dusty's daughter, Sandy, lives in the Vistas Bonitas Subdivision
10	where the park is located.
11	NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE
12	CITY OF SANTA FE that the Vistas Bonitas subdivision park be named Dawson Park in
13	recognition of the contributions made by Bill and Dusty Dawson.
