A. CALL TO ORDER

The Archaeological Review Committee Hearing was called to order by David Eck, Chair, at approximately 3:30 p.m., on Thursday, May 7, 2020, via virtual attendance on Zoom, streaming live on the City of Santa Fe's YouTube Channel at <https://www.youtube.com/user/city of Santa Fe>, City of Santa Fe, New Mexico.

The following correction was made to the minutes:

Page 41, paragraph 2, line 3, correct: He said, "he This property came within one vote of being declared significant in the Santa Fe District by the Historic Design Review Board. However, under the criteria of historic figures, he thinks it would be hard to argue that [inaudible] significant designation is not valid, but it is contributing with almost all façades being primary. He said most of that took place in the 1950's, and he believes this would be eligible at least for the State Register of Historic Properties, but probably not the National. "So I would argue strongly about that statement."

Mr. Pierce said Ms. Helberg is to be commended for doing a great job under difficult circumstances.

1. **CASE #2020-002013-ARC. RON WINTERS, AGENT FOR KELLY CABLE, REQUESTS APPROVAL OF AN ARCHAEOLOGICAL MONITORING PLAN FOR THE PROPOSED CENTURYLINK PROJECT AT EAST PALACE AVENUE AND CIENEGA STREET IN THE HISTORIC DOWNTOWN ARCHAEOLOGICAL REVIEW DISTRICT. (LISA ROACH, lxroach@santafenm.gov. 955-6657)**

BACKGROUND & SUMMARY:

Ron Winters presents an archaeological monitoring plan for the installation of subsurface fiber by boring at East Palace Avenue and Cienega Street in the Historic Downtown Archaeological District. The proposed project begins from an existing manhole at the southeast corner of East Palace Avenue and Cienega Street and proceeds by subsurface boring north along the east side of Cienega Street for 170 linear feet to a new handhole. The project will then bore east 50 linear feet to a new handhole, and then bore 20 linear feet further to a new JBOX. As the bore pits are excavated, the fill and pit walls will be examined for evidence of cultural resources, including features and deposits. Any resources encountered will be documented within the pit, and cable will be installed and the pits backfilled. A final report will be presented for ARC review and clearance.

STAFF RECOMMENDATION:

Staff recommends approval of the monitoring plan, as it meets the intent of the City of Santa Fe Archaeological Review District Ordinance (14-5.3) and the requirements of Archaeological Clearance Permits (14-3.13).

Chair Eck noted the staff report in the packet. He thanked Ms. Roach and asked if she has anything to add.

Ms. Roach said she had nothing to add.

Responding to the Chair, Mr. Winters said by doing the NMCRIS search, he found a site in close proximity, LA 174243, although there was no description. The client has requested a floor on this project because of the pushback they got from the City about taking up the sidewalk if needing to trench that. He said back to the site mentioned, it won't be impacted by this scope of work as the project will begin from an existing manhole on the south side of the street and go to the new handhole 170 feet north.

Dale Zinn

Mr. Zinn had no comment.

Cortney Wands

Ms. Wands asked about LA 174243 potentially going through the site.

Mr. Winters said from what he could tell on the ground, it looked like it went down the center of street. He could find no further information based on the NMCRIS search, so he can't tell exactly with those site forms where it travels. In the bore, normally they will say 4-5 feet below the ground surface. He said he can't say for a fact that it wouldn't impact them, but part of that has to do with not being able to get a description of it.

Ms. Wands asked if he contacted the OAS about getting a description of this site, and Mr. Winters said he did not.

Ms. Wands said, in the description of his method, Mr. Winters seems to focus on the trenching.

Mr. Winters said, "No. There is a small amount of trenching, but most of it is a bore."

Ms. Wands said she assumes his methods are the things he would do during trenching and not boring.

Mr. Winters said he thought he included the boring, but he will do so.

Jake Ivey

Mr. Ivey had no comment.

Derek Pierce

Mr. Pierce said he has no comment.

Chair Eck

Chair Eck said the only thing he would offer to follow up on Ms. Wands' questions, he would strongly encourage Mr. Winters to contact OAS to try to give us a direct idea of what it is, exactly where, how it is defined and be clear before the project begins as to any chance of it being a factor during your monitoring.

Public Comment

There was no public comment.

MOTION: Jake Ivey moved, seconded by Dale Zinn, with respect to Case #2020-002013-ARC, to approve the Archaeological Monitoring Plan for the proposed CenturyLink project at East Palace Avenue and Cienega Street, in the Historic Downtown Archaeological Review District, as requested by Ron Winters for Kelly Cable, with the suggestion that Mr. Winters approach the Office of Archaeological Studies prior to work beginning for additional information about the specifics of those sites, LA174243 and LA 174241, and whether there would be an impact, to ward off any surprises, as it meets the intent of the City of Santa Fe Archaeological Review District Ordinance (14-5.3) and the requirements of Archaeological Clearance Permits (14-3.13).

DISCUSSION: Ms. Roach asked Ms. Wands what is the site that is of concern.

Ms. Wands said LA 174243 runs down Palace Avenue, but LA 174241 runs down Cienega, noting they are perpendicular to one another, and they were found in backhoe trenches themselves.

Mr. Winters said, "I would say, I know that they went down Palace in the street and in the street on Cienega, and before we were planning on doing the starting at the manhole and going under the sidewalk there. So that doesn't mean that no site extends beyond, but it is a slightly different location. " So it would be great to find out what Derek knows about that, if he can tell me, so I can be aware of that." He said he agrees with the Chair's remarks.

Ms. Wands said she also agreed.

Chair Eck said the key to the information would be the depth that plays off against the proposed bore. As long as you are going deeper than that, you will probably successfully avoid it.

Ms. Wands asked to verify that the motion is to approve the monitoring plan with the suggestion that the archaeologist contact the Office of Archaeological studies for further information on LA174243, LA 174241, prior to work beginning.

Chair Eck said that is correct.

2. **CASE #2020-002014-ARC. RON WINTERS, AGENT FOR ORALYNN GUERRERORTIZ, REQUESTS APPROVAL OF AN ARCHAEOLOGICAL RECONNAISSANCE REPORT FOR 8.37 ACRES WITHIN A PORTION OF S.H.C. 1229, FOR A PROPOSED DEVELOPMENT ON KATE'S WAY IN THE RIVER AND TRAILS ARCHAEOLOGICAL REVIEW DISTRICT. (LISA ROACH, STAFF LIAISON)**

BACKGROUND & SUMMARY:

Ron Winters presents an archaeological reconnaissance report for the survey of an 8.387 parcel in advance of a proposed development on Kate's Way in the River and Trails Archaeological Review District. During the course of the visual inspection, eight isolated occurrences and a historic roadbed were documented. The property was not determined to hold potential for additional information on the prehistory or history of Santa Fe and no further investigation is recommended.

STAFF RECOMMENDATION:

Staff recommends approval of the reconnaissance report, as it meets the intent of the City of Santa Fe Archaeological Review District Ordinance (14-5.3) and the requirements of Archaeological Clearance Permits (14-3.13).

Chair Eck noted the staff report in the packet. He thanked Ms. Roach and asked if she has anything to add.

Ms. Roach said she had nothing to add.

Chair Eck said he would suggest that people refrain from using the word "determined" prior to the consideration of any entities reported, documented and presented to this Committee until this Committee has had it's say. He said contractors do not make a determination.

Responding to the Chair, Mr. Winters said, "The description of the DCPI 48479 is limited, given that all the City or State were aware of historical background research would normally be conducted were closed. And so a lot of that information is not available on mine. I was in contact with the BLM and researched the Government Land Office site. I did get the Township Range and the action *[inaudible]* that you see there. And I also looked at the field notes for the area and didn't see any reference to this road." He said he is "basing the relative age of the road bed on its structure and the lack of use in recent years. So, like I said, I don't have a lot to say about it. It certainly was historic based on the associated artifacts, and given the physical appearance."

Dale Zinn

Responding to Mr. Zinn, Mr. Winters said the site is about 500 feet from this, "but the only thing that might have been was on aisle one where there were a few fragments from metal cans, which may be background noise from that site. The site didn't go all the way to Kate's Way on the east."

Mr. Zinn said this would give context on the background and history of Santa Fe that we don't know much about, and it very well then may have been farm and ranch stuff that started overlapping historic stuff. "So I just wanted to thank you for the great story on the history of horses."

Cortney Wands

Ms. Wands suggested that we record this site for future reference.

Jake Ivey

Mr. Ivey said he was interested in the silver horseshoe, but has no other comment.

Derek Pierce

Mr. Pierce said, "I have no comment on this case."

Chair David Eck

Chair Eck congratulated Mr. Winters on the use of new and different reference material for his discussion of the Project Area and Environment on packet page 10. However, the citations referred to were not in his References Cited. He said the reference to *Dick-Peddie* 1993 does not appear in the References Cited, and the reference to the *NRCS* 2016 given in the text does not appear

Mr. Winters said he will make the corrections.

Chair Eck said on packet page 21, in the paragraph at the top, there is the statement that *"One of the sites occurs within close proximity to the project area (LA76232) although it is not what was originally described."* He asked how Mr. Winters happens to know this, commenting it would be good to have a citation to yourself to explain why you made that statement."

Mr. Winters said he will make that correction.

Chair Eck said on packet page 33, paragraph 1, Mr. Winters says, “*An abandoned historic road HCPI48479) that runs along the eastern edge of the project area...*” but his illustration seems to show it running almost down the middle of the project area. And in paragraph 1 he refers to Figure 9, but he never refers to Figure 10 which actually says where the alignment is on the plat. “So, I think perhaps you should revamp your geography and include a citation for Figure 10.

Mr. Winters said he will make that correction.

3. **CASE #2020-002015-ARC. OFFICE OF ARCHAEOLOGICAL STUDIES, AGENT FOR CONTERRA NETWORK, REQUESTS APPROVAL OF AN ARCHAEOLOGICAL MONITORING PLAN FOR THE INSTALLATION OF 2,380 LINEAR FEET OF SUBSURFACE CONDUIT AT ZIA ROAD IN THE SUBURBAN ARCHAEOLOGICAL REVIEW DISTRICT. (LISA ROACH, STAFF LIAISON)**

BACKGROUND & SUMMARY:

The Office of Archaeological Studies presents an archaeological monitoring plan in advance of the installation of subsurface conduit for the extension of broadband communications services on Zia Road between St. Francis Drive and the eastern side of Milagro Middle School campus in the Suburban Archaeological Review District. Boring is proposed where possible beneath city streets and the right-of-way along the north side of Zia Road. The total length of the project is 2,380 linear feet, beginning at the northeast corner of Zia Road and St. Francis Drive and continuing east to the eastern side of the former Milagro Middle School. Four handholes, measuring 3 feet x 4 feet will be placed along the route and excavated to a depth of 3 feet. Any cultural features and deposits encountered will be documented, and a report provided at the conclusion of the project.

STAFF RECOMMENDATION:

Staff recommends approval of the monitoring plan, as it meets the intent of the City of Santa Fe Archaeological Review District Ordinance (14-5.3) and the requirements of Archaeological Clearance Permits (14-3.13).

Chair Eck noted the staff report in the packet. He thanked Ms. Roach and asked if she has anything to add.

Ms. Roach said she had nothing to add.

Responding to the Chair, Dr. Blinman said he doesn't think there is much to add on this, again, lots of boring beneath well developed City streets.

OFFICE OF ARCHAEOLOGICAL STUDIES, AGENT FOR HIGH 5 NETWORKS, REQUESTS APPROVAL OF AN ARCHAEOLOGICAL MONITORING PLAN FOR THE INSTALLATION OF 657 LINEAR FEET OF SUBSURFACE CONDUIT ALONG WEST SAN FRANCISCO STREET, IN THE HISTORIC DOWNTOWN ARCHAEOLOGICAL REVIEW DISTRICT. (LISA ROACH, STAFF LIAISON)**

BACKGROUND & SUMMARY:

The Office of Archaeological Studies presents an archaeological monitoring plan in advance of the installation of subsurface conduit as part of Comcast network improvements on West San Francisco Street in the Historic Downtown Archaeological Review District. Installation will be performed via trenching from an existing vault on Sandoval Street to the project terminus at 411 West San Francisco Street. Three new vaults will be placed along the route on the north side of West San Francisco Street. The trench will be 24 inches wide to a target depth of 24 inches for a total length of 657 linear feet. Vaults will measure 36 inches by 24 inches excavated to a depth of 36 inches. Any cultural features and deposits encountered will be documented, and a report provided at the conclusion of the project.

STAFF RECOMMENDATION:

Staff recommends approval of the monitoring plan, as it meets the intent of the City of Santa Fe Archaeological Review District Ordinance (14-5.3) and the requirements of Archaeological Clearance Permits (14-3.13).

Chair Eck noted the staff report in the packet. He thanked Ms. Roach and asked if she has anything to add.

Ms. Roach said she had nothing to add.

Responding to the Chair, Karen Wening, Archaeologist, offered the following corrections:

Packet page 26, paragraph 1, add to the last sentence, "...from 1908 to 1967 when Guadalupe Street was widened."

5. **CASE #2020-001921-ARC. OFFICE OF ARCHAEOLOGICAL STUDIES, AGENT FOR THE CITY OF SANTA FE, REQUESTS APPROVAL OF AN ARCHAEOLOGICAL TESTING AND MONITORING PLAN FOR THE INSTALLATION OF THE TESUQUE RUNNERS SCULPTURE GARDEN AT THE SANTA FE COMMUNITY CONVENTION CENTER IN THE HISTORIC DOWNTOWN ARCHAEOLOGICAL REVIEW DISTRICT. (LISA ROACH, STAFF LIAISON)**

BACKGROUND & SUMMARY:

The Office of Archaeological Studies presents an archaeological testing and monitoring plan in advance of the installation of the Tesuque Runners Sculpture Garden at the Santa Fe Community Convention Center, 201 West Marcy Street, in the Historic Downtown Archaeological Review District. The City of Santa Fe proposes to install a sculpture commemorating the role of two runners from the Pueblo of Tesuque in the Pueblo Revolt of 1680. The proposed Tesuque Runners Sculpture Garden will be placed at the eastern edge of the Santa Fe Community Convention Center, in front of the west wing of Santa Fe City Hall. The project area is within the boundaries of LA 1051, a significant archaeological site that is eligible for inclusion on the the State Register of Cultural Properties. Testing and monitoring are proposed to determine whether proposed construction will encounter intact cultural resources within the project area.

STAFF RECOMMENDATION:

Staff recommends approval of the testing monitoring plan, finding that it meets the intent of the City of Santa Fe Archaeological Review District Ordinance (14-5.3) and the requirements of Archaeological Clearance Permits (14-3.13).

Chair Eck noted the staff report in the packet. He thanked Ms. Roach and asked if she has anything to add.

Ms. Roach said the contract for this project is being issued by the Land Use Department in coordination with the Arts and Culture Department. She has no further remarks.

Responding to the Chair, Dr. Blinman said, "This is one of these projects that reveals some of the major weaknesses in the performance of my own office, as well as in a lot of the background documentation that we would love to be able to rely on NMCRIS for, but it's only as good as what gets put into it. So, I will be working upgrade the quality of the information on 1051 at the conclusion of this project."

Chair Eck asked Dr. Blinman if there are details that he needs to pointed-out.

Dr. Blinman said, "Nothing that I didn't try to include in the plan."

Dale Zinn

Mr. Zinn said this is a great project.

Cortney Wands

Ms. Wands there are great maps in the report, but has no comments otherwise.

Mr. Pierce said he thinks this is a great plan, and he has no concerns.


