5	AN ORDINANCE
6	AMENDING SECTION 23-6.2 SFCC 1987 TO EXTEND THE TIME PERIOD FOR
7	WHICH ESTABLISHMENTS THAT HAVE OBTAINED AN OBSTRUCTION PERMIT
8	FROM THE CITY AND A TEMPORARY CHANGE/EXPANSION OF LIQUOR LICENSE
9	PREMISES FROM THE NEW MEXICO ALCOHOLIC BEVERAGE CONTROL
10	DIVISION MAY SERVE ALCOHOL ON CITY SIDEWALKS, STREETS, RIGHTS-OF-
11	WAY, OR OTHER PROPERTY THAT HAS BEEN SPECIFICALLY AUTHORIZED FOR
12	TEMPORARY USE DUE TO THE COVID-19 PUBLIC HEALTH EMERGENCY AND ITS
13	EFFECTS.

15	BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF SANTA FE:
16	Section 1. Section 23-6.2 of SFCC 1987 (being Ord. No. 2012-20, as amended) is
17	amended to read:
18	23-6.2 Permitted locations for the sale and consumption of alcohol on city property.
19	A. The sale or consumption of alcoholic beverages is permitted at the following
20	locations on city property:
21	(1) The Santa Fe community convention center and adjacent outdoor
22	spaces under the center's control;
23	(2) That area of the Santa Fe regional airport main terminal building and
24	adjacent areas operated as a restaurant;
25	(3) The Marty Sanchez links de Santa Fe (golf course);

1	(4) Buildings owned by another party located on land owned by the city;
2	(5) On land or buildings owned by the city, located within the Santa Fe
3	Railyard, as described in the Railyard Master Plan, for which the city has entered into
4	a lease with another party for six (6) months or more except for the Railyard park, Plaza
5	and Alameda (as defined in the Deed of Conservation Easement dated October 1, 2004)
6	where alcohol is prohibited, unless specifically permitted under subsection 23-
7	6.2 SFCC 1987;
8	(6) On land or buildings owned by the city for which the city has entered
9	into a lease with another party for six (6) months or more;
10	(7) In or on railroad cars located on railroad tracks except as prohibited by
11	state or federal law; and
12	(8) During professional baseball games, the area of Fort Marcy ballpark
13	designated for concessions and seating.
14	B. The only alcohol sales and consumption permitted at Fort Marcy ballpark are
15	beer and wine.
16	C. The governing body may approve by resolution the sale and consumption of
17	alcohol at all other locations on city property, except within the Plaza as defined by
18	subsection 23-5.1(S). The resolution specifying the event, date, hours, location, number of
19	expected attendees, type of alcohol to be served, required permits, and insurance shall be
20	adopted at least thirty (30) days in advance of the event. The resolution shall be limited to
21	authorization for a single event, unless otherwise stated in the resolution.
22	D. All other applicable approvals required by state or city laws and regulations
23	shall be obtained prior to the sale or consumption of alcoholic beverages on the property
24	described in this subsection 23-6.2.
25	E. As a response to the May 27, 2020, public health order issued by the New Mexico

department of health allowing limited outdoor dining service for qualified restaurants, and to enhance physical distancing restrictions due to the COVID-19 pandemic, sale and consumption of alcohol on any city sidewalk, street, right-of-way, or other specified property that has been designated and approved for temporary use by a current liquor licensee may occur pursuant to the following limitations: 1. A licensed establishment shall obtain and maintain a general liability policy in the amount of one million dollars (\$1,000,000.00) and a liquor liability policy in the amount of two million dollars (\$2,000,000.00) and must name the city, officers,

employees, and agents as additional insureds.

2. The licensed establishment must apply for and receive an obstruction permit from the city that includes the requirement to indemnify the city.

3. The licensed establishment must also obtain a temporary change/expansion of liquor license premises issued by the alcoholic beverage control division of the New Mexico regulation and licensing department. Proof of the approved temporary change/expansion of liquor license premises must be produced upon request of police, fire, or other authorized city official.

4. The sale and consumption of alcoholic beverages on any city property allowed under this subsection shall be subject to the regulations concerning alcoholic beverages contained in SFCC Section 4-2, 1987.

5. Unless extended by ordinance or resolution, any license or permit issued pursuant to this subsection shall expire on October 31, 2021.
