**A RESOLUTION**

**AUTHORIZING THE SALE AND CONSUMPTION OF BEER AND WINE AT THE MONTEZUMA POCKET PARK FOR THE SKY RAILWAY GRAND OPENING ON SEPTEMBER 3 AND 4, 2021, PURSUANT TO SECTION 23.6.2(C) SFCC 1987.**

**WHEREAS**, the Governing Body adopted Ordinance No. 2017-3 on March 8, 2017 that created a new process for approving the sale and consumption of alcohol on city property, which is codified as Section 23-6.2(A); and

**WHEREAS**, for locations not specifically mentioned in Section 23-6.2(A) SFCC 1987, the ordinance requires the approval by the Governing Body of a resolution that specifies the event, date, hours, location, number of expected attendees, type of alcohol to be served, and require permits must be requested 30 days prior to the event; and

**WHEREAS**, Highgarden Entertainment, LLC, desires to operate a beer and wine garden on the weekend of September 3-4, 2021, at the Montezuma Pocket Park in conjunction with the Sky Railway grand opening; and

**WHEREAS**, the Montezuma Pocket Park is a City of Santa Fe Park at which alcohol is

1 not usually served; and

2 **WHEREAS**, Highgarden Entertainment, LLC, has committed to providing alcohol service  
3 for this event that would adhere to all regulations required in Section 23-6.3 SFCC 1987.

4 **NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE**  
5 **CITY OF SANTA FE** that alcohol service for the following event is hereby approved:

6 Event: Sky Railway Grand Opening

7 Date: September 3-4, 2021

8 Hours: 12 p.m. to 10:00 p.m. Friday and 12 p.m. to 10:00 p.m. Saturday

9 Location: Montezuma Pocket Park (located directly to the east of the Jean Cocteau Cinema  
10 between the building located at 418 Montezuma Avenue and the railroad tracks)

11 Number of Expected Attendees: 130

12 Type of Alcohol to be served: beer and wine

13 Required Permits: Special Dispenser Permit

14 Required Insurance: liquor liability insurance in the amount of \$1,050,000.00
