19	Section 2. The official zoning map of the City of Santa Fe adopted by Ordinance No.
20	2001-27 is amended to conform to the changes of zoning classifications for the property set forth
21	in Section 1 of this Ordinance.
22	Section 3. This Ordinance shall be published one time by the title and general summary
23	and shall become effective five days after such publication.
24	Section 4. The rezoning action with respect to the Property affected by this Ordinance is
25	subject to the time restrictions set forth in Section 14-3.5(D)(1) SFCC 1987 (Two-year
