6	AMENDING SECTIONS 9-1.2, 9-1.3, AND 9-1.4.1 SFCC 1987 REGARDING THE
7	ELECTION CODE.

9	BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF SANTA FE:
10	Section 1. Section 9-1.2 SFCC 1987 (being Code 1973, §1-13 as amended) is
11	amended to read:
12	9-1.2 Conduct of Elections.
13	Municipal elections in the city shall be conducted in accordance with the Santa Fe
14	Election Code, the Santa Fe Municipal Charter and the New Mexico Municipal Election Code,
15	being Sections 3-8-1 through 3-9-16 NMSA 1978.
16	Section 2. Section 9-1.3 SFCC 1987 (being Ord. #1985-60, §3; as amended) is
17	amended to read:
18	9-1.3 Creation of Districts.
19	A. Except as otherwise provided by ordinance, city councilors shall reside in and be
20	elected from municipal election districts.
21	B. The resident qualified electors in each of the four (4) municipal election districts
22	shall elect one (1) city councilor from each district for a four (4) year term, so that each municipal
23	election district is represented by two (2) city councilors serving staggered four (4) year terms.
24	C. There are created four (4) two (2)-member municipal election districts which
25	include the following precincts and portions of precincts located within the municipal boundaries

1	of the city of Santa Fe:
2	(1) District 1: Precincts 8, 9, 10, 11, 20, 21, 22, 24, 25, 26, 27, 28, 30 and 8
3	(2) District 2: Precincts 36, 37, 42, 43, 44, 45, 46, 47, 48, 52, 53, 54 and 55
4	(3) District 3: Precincts 12, 31, 32, 33, 34, 41, 62, 64, 66, 67, 75, 80 and 86
5	(4) District 4: Precincts 29, 35, 38, 39, 49, 50, 51, 56, 74, 76, 77 and 78.
6	D. The boundaries of each municipal election district are shown on the municipal
7	election district map revised as of October 10, 2007 which is hereby adopted as the official
8	districting map and is to be kept in the custody of the municipal clerk.
9	Section 3. Section 9-1.3 SFCC 1987 (being Ord. #2002-7, §§4, 5) is amended to
10	read:
11	9-1.4.1 Incorporation by Reference.
12	The approved redistricting plan and plan documents (subsections 9-1.3 and 9-1.4)
13	presented to and utilized by the governing body at the January 28, 2002 meeting in the course
14	revising the boundaries of the four (4) city council districts are incorporated by reference. A true
15	and correct copy of said plan and plan documents shall be retained by the city clerk and made
16	available for inspection by the public.
