Section 24-2.6 SFCC 1987 (being Ord. #2006-14, §26) is amended to 12 read: 13 24-2.6 Restricted Traffic. 14 A. Trucks, truck trailers and other large vehicles with a gross vehicle weight of five 15 (5) tons or more are prohibited from traveling on the following streets except as set forth in 16 paragraphs B. and C. below: 17 (1) Agua Fria Street, between Siler Road and Guadalupe Street except those 18 vehicles making pickups or deliveries to addresses on adjacent dead end streets; 19 (2) Alamo Drive; 20 (3) Apache Street; 21 (4) Armenta Street; 22 (5) Arroyo Chamiso, Botulph and beginning at the eastern boundary of Zia 23 Road; 24 (6) Calle Atajo: 25 (7) Calle La Resolana;

25	addresses on the	e specific streets or to addresses on adjacent streets served only by that

I	specific street(s); or		
2	(2) The vehicle is traveling to or from such addresses for the purposes of		
3	locating permanently or temporarily at such addresses provided they are in compliance		
4	with any other applicable city code.		
5	C. Authorized emergency vehicles; any government or utility maintenance, service		
6	and transportation vehicles; and school buses, with a gross vehicle weight of five (5) tons or		
7	more, are permitted to travel on the streets specified above.
