Project participation agreement means an agreement between a qualifying entity and the 21 city whereby the city provides assistance to an economic development project in exchange for the 22 23 benefits received as set forth in this section. Qualifying entity means a corporation, limited liability company, partnership, joint 24 venture, syndicate, association or other person that is one or a combination of two (2) or more of 25
