5 AN ORDINANCE

6 AMENDING SECTION 24-2.6 SFCC 1987 TO RESTRICT TRUCK, TRUCK TRAILER
7 AND OTHER LARGE VEHICLE TRAFFIC ON JAY STREET; NAVAJO DRIVE;
8 QUAPAW STREET; AND VIA ANTIGUA.

10 BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF SANTA FE:

11 Section 1. Section 24-2.6 SFCC 1987 (being Ord. #2006-14, §26) is amended to
12 read:

13 24-2.6 Restricted Traffic.

14 A. Trucks, truck trailers and other large vehicles with a gross vehicle weight of five
15 (5) tons or more are prohibited from traveling on the following streets except as set forth in
16 paragraphs B. and C. below:

17 (1) Agua Fria Street, between Siler Road and Guadalupe Street except those
18 vehicles making pickups or deliveries to addresses on adjacent dead end streets;

19 (2) Alamo Drive;

20 (3) Apache Street;

21 (4) Armenta Street;

22 (5) Arroyo Chamiso, Botulph and beginning at the eastern boundary of Zia
23 Road;

24 (6) Calle Atajo;

25 (7) Calle La Resolana;

- 1 (8) Camino Carlos Rey between Siringo Road and Zia Road;
- 2 (9) Camino Consuelo;
- 3 (10) Camino de las Crucitas;
- 4 (11) Camino Encantado;
- 5 (12) Camino Lejo between Old Pecos Trail and Old Santa Fe Trail;
- 6 (13) Canyon Road;
- 7 (14) Catron Street;
- 8 (15) Circle Drive between Bishops Lodge Road and Camino Encantado;
- 9 Escalante Street;
- 10 (16) Espinacitas Street between St. Michael's Drive and Jay Street;
- 11 (17) Fifth Street between St. Michael's Drive and Cerrillos Road;
- 12 (18) Fourth Street between Jay Street and Quapaw Street;
- 13 (19) Galisteo Street between Paseo de Peralta and St. Michael's Drive;
- 14 (20) Gonzales Road, north of Hyde Park Road;
- 15 (21) Governor Miles – those portions located within the city limits as follows:
- 16 (a) From just west of Chamisa Path Road to east of Dancing Ground
- 17 Street; and
- 18 (b) From west of Nizhoni Drive to the terminus of Governor Miles
- 19 Road located east of Camino Carlos Rey.
- 20 (22) Hillside Avenue;
- 21 (23) Hopewell Street between Second Street and Sixth Street;
- 22 (24) Jaguar Drive between Country Club Road and Cerrillos Road;
- 23 (25) Jay Street;
- 24 (26) Jefferson Street;
- 25 (27) Lujan Street;

- 1 (28) Maez Road;
- 2 (29) Mann Street from Sixth Street to its terminus;
- 3 (30) Morelia Street between Cordova Road and Alta Vista Street;
- 4 (31) Navajo Street south of Taos Street;
- 5 (32) North El Rancho Road between West Alameda Street and Paseo De Vista;
- 6 (33) Osage Avenue;
- 7 (34) Placita de Oro;
- 8 (35) Quapaw Street;
- 9 (36) Rio Vista Street;
- 10 (37) San Mateo Road from St. Francis Drive to Old Pecos Trail;
- 11 (38) Solana Drive;
- 12 (39) South Meadows to Camino Cesar E. Chavez (formerly Airport Road);
- 13 (40) Staab Street;
- 14 (41) Third Street between Hopewell Street and Jay Street;
- 15 (42) Valley Drive between Bishop's Lodge Road and Vallecita Drive;
- 16 (43) Via Antigua;
- 17 (44) Vitalia Street;
- 18 (45) West Alameda Street west of the landfill road to the city limits except those
- 19 vehicles making pickups or deliveries to addresses on adjacent dead end streets; and
- 20 (46) Zia Road.

21 B. Trucks, truck trailers and other large vehicles with a gross vehicle weight of five

22 (5) tons are not prohibited provided the following are met:

- 23 (1) The vehicle is making pick-up and deliveries or providing services to
- 24 addresses on the specific streets or to addresses on adjacent streets served only by that
- 25 specific street(s); or

1 (2) The vehicle is traveling to or from such addresses for the purposes of
2 locating permanently or temporarily at such addresses provided they are in compliance
3 with any other applicable city code.

4 C. Authorized emergency vehicles; any government or utility maintenance, service
5 and transportation vehicles; and school buses, with a gross vehicle weight of five (5) tons or
6 more, are permitted to travel on the streets specified above.




