16	Permits for residential construction shall expire one (1) year from the date of issuance		
17	and permits for commercial construction shall expire two (2) years from the date of issuance.		
18	Infrastructure permits, specifically grading and drainage permits and landscape and utility		
19	permits, for either residential or commercial construction shall expire two (2) years from date of		
20	issuance. The governing body by adoption of a resolution may approve the temporary suspension		
21	of the enforcement of this section due to severe economic conditions. The suspension may be		
22	retroactive to a date certain and may impose certain conditions. This authority shall not be used		
23	for specific building permits or individual economic situations, but shall apply to all building		
24	permits due to broad economic downturns.
