5 AN ORDINANCE

6 AMENDING PARAGRAPH I. OF SECTION 23-7.4 SFCC 1987 REQUIRING LEAGUES  
7 USING THE MUNICIPAL RECREATION COMPLEX AND MUNICIPAL PARKS  
8 SPORTS FIELDS TO SUBMIT BYLAWS AND FINANCIAL STATEMENTS.

9  
10 BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF SANTA FE:

11 Section 1. Paragraph I. of Section 23-7.4 SFCC 1987 (being Ord. #1996-32, §4  
12 as amended) is amended to read:

13 I. *MRC and Municipal Park Sports Fields:*

14 (1) Annual fifteen dollars (\$15.00) fee for youth team/league  
15 participants, ten (10) years or older, allowing for unlimited participation for one  
16 (1) year in all leagues. Annual ten dollars (\$10.00) fee for youth team/league  
17 participants, under the age of ten (10), allowing for unlimited participation for  
18 one (1) year in all leagues.

19 (2) Sports field use:

20 (a) All adult teams participating in league events are to pay  
21 a one hundred dollar (\$100.00) fee for yearly field maintenance/utilities  
22 plus twenty-five dollars (\$25.00) per player necessary to field a team  
23 according to their individual league plus twenty-five dollars (\$25.00) for  
24 one (1) alternate player.

25 (b) Seventy-five dollars (\$75.00) per field per day.

1 (c) Lighting will be thirty dollars (\$30.00) per hour per  
2 field, as needed.

3 (d) All concessions will be provided through the city.

4 (e) Municipal sports park fields, exclusive of the MRC, will  
5 be prioritized for youth leagues with adult league use scheduled as  
6 available. MRC fields will be prioritized for adult leagues with youth  
7 league use scheduled pursuant to paragraph (f) below.

8 (f) In the event that other municipal sports park fields are  
9 unavailable to accommodate youth leagues or youth tournaments, and the  
10 MRC fields are not scheduled for use pursuant to paragraph I. above,  
11 then the MRC fields may be made available to provide a field for such  
12 event.

13 (g) MRC and municipal sports park field user fees and other  
14 rates will be reviewed on an annual basis.

15 (3) Annual twenty-five dollar (\$25.00) fee for adult participants  
16 allowing for unlimited non-league participation at the MRC for one (1) year.

17 (4) Fees collected for the use of municipal sports park fields at the  
18 MRC shall be deposited into the MRC fund. Fees collected for municipal sports  
19 park fields other than the MRC shall be deposited into the city's general fund.


20 (5) All leagues shall submit with their application the following:

21 (a) A copy of the league's bylaws or other document  
22 demonstrating how the league was organized and operates. Such  
23 document shall be made available to all league participants.

24 (b) A current financial statement regarding the league's  
25 financial status including information regarding participant fees, account


1 balances and a budget indicating expenses and revenues.


