5 AN ORDINANCE

6 AMENDING SECTION 6-17.3 SFCC 1987 REGARDING MEMBERSHIP REQUIREMENTS  
7 FOR THE CITY BUSINESS AND QUALITY OF LIFE COMMITTEE.

9 BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF SANTA FE:

10 Section 1. Section 6-17.3 SFCC 1987 (being Ord. #2005-5, §4) is amended to  
11 read:


12 **6-17.3 Membership; Terms.**

13 A. Membership. The city business and quality of life advisory committee shall be  
14 composed of twelve (12) members residing in Santa Fe County and qualified by training,  
15 experience, and ability to exercise sound and practical judgment regarding those powers and  
16 duties of the committee. The members shall be appointed by the mayor with the advice and  
17 consent of a majority vote of all the members of the governing body. The members shall include  
18 two (2) members of the governing body; the chairman or one (1) other member of the economic  
19 development review committee established in subsection 11-11.6 SFCC 1987; and nine (9) other  
20 members representing a broad range of business interests, including small and large businesses,  
21 within the city including, but not limited to: arts and culture industries; development, design, and  
22 construction; hospitality; technology; retail trade and services; and a broad range of community  
23 interests, from organizations such as neighborhood associations or related groups; preservation  
24 organizations; environmental organizations; open space organizations; recreational organizations;  
25 and arts organizations. The members of the governing body shall serve as chairperson and vice

1 chairperson as appointed by the mayor. A quorum shall be at least seven members. Members  
2 shall serve without compensation.


3 B. Terms. Of the initial appointments, six (6) of the members shall be appointed for  
4 one (1) year terms and six (6) shall be appointed for two (2) year terms. Subsequent terms shall  
5 be for two (2) years to maintain staggering of terms. There shall be no limitation to the number of  
6 consecutive terms a member may serve. Failing to attend three (3) consecutive regular meetings  
7 or failing to attend thirty-three percent (33%) or more of the regular meetings in any year shall  
8 constitute an automatic tender of resignation by such member, which the governing body may  
9 accept or reject in its discretion. Vacancies, other than by expiration of terms, shall be filled for  
10 the unexpired term in the same manner as original appointments.


