11	REPEALING RESOLUTION NO. 2005-10 AND RE-ESTABLISHING THE 400 TH
12	ANNIVERSARY COMMITTEE TO PLAN FOR THE FOUR-HUNDRED YEAR
13	ANNIVERSARY OF THE FOUNDING OF LA VILLA REAL DE LA SANTA FE, 1607
14	THROUGH 1610.

16	WHEREAS, on January 26, 2005 the Governing Body adopted Resolution No. 2005-10
17	which re-established the 400 th Anniversary Committee; and
18	WHEREAS, in order to collaborate with our neighboring pueblos in planning the 400 th
19	Anniversary of the founding of La Villa Real de la Santa Fe, the Governing Body desires to re-
20	establish the 400 th Anniversary Committee; and
21	WHEREAS, in 2010, Santa Fe shall proudly observe its 400 th anniversary, 1607-2010,
22	with suitable events and observances by the citizenry of Santa Fe to commemorate its first four
23	hundred years and to pass on to their children and grandchildren the Indo-Hispano heritage; and
24	WHEREAS, the Governing Body wishes to re-establish the 400th Anniversary
25	Committee in order to prepare for the 400 th Anniversary of La Villa Real de la Santa Fe from

2007-2010 on behalf of the people of Santa Fe and northern New Mexico; and

WHEREAS, the 400th Anniversary Committee is meant to be an honorary committee composed of citizens who will guide and direct this preparation; and

WHEREAS, the Governing Body recognizes the need for two tiers of the Committee in order for it to work in the most efficient and effective manner: the 400th Anniversary Committee and its subcommittee(s).

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF SANTA FE that Resolution No. 2005-10 is repealed.

BE IT FURTHER RESOLVED that:

- Section 1. NAME. The 400th Anniversary Committee is hereby formed.
- Section 2. PURPOSE. The purpose of the 400th Anniversary Committee is to plan for the City's 400th anniversary, 2007 2010.

Section 3. DUTIES AND RESPONSIBILITIES.

- A. The Committee will accomplish its purpose by establishing subcommittee(s), as needed, which will develop and implement projects and programs, under the guidance and direction of the committee, for the City of Santa Fe's 400th anniversary that are consistent with the importance of the occasion and that show respect for the collective heritage of the community. Such projects and programs include, but are not limited to, educational initiatives, symposia and public events.
- B. The 400th Anniversary Committee is authorized to work closely with Santa Fe 400th Anniversary Committee, Inc., a nonprofit organization, for the purpose of commemorating the founding of La Villa Real de la Santa Fe.
- Section 4. DURATION. The 400th Anniversary Committee shall exist from the adoption of this Resolution until its final report to be made to the Governing Body no later than the end of March, 2011 unless additional time is approved by the Governing Body.

1	Section 5. MEMBERSHIP. The 400 th Anniversary Committee shall consist of
2	eleven members appointed by the Mayor with the advice and consent of the City Council.
3	Members shall reside in the state of New Mexico. The chairperson shall be appointed by the
4	Mayor. Vacancies on the committee shall be appointed in the same manner. The committee shall
5	serve at the pleasure of the Mayor and members may be removed at any time, with or without
6	cause. The committee and its subcommittee(s) shall represent the broadest range of individuals,
7	organizations, pueblos and governments. The subcommittee(s) shall include an appropriate city
8	staff member designated by the City Manager.
9	Section 6. MEETINGS. The 400 th Anniversary Committee shall meet from time to
10	time as needed, and at least four (4) times per calendar year to carry out the purpose and duties
11	and responsibilities charged to it by adoption of this Resolution.
