11	AMENDING ARTICLE 11-4 SFCC 1987 TO AUTHORIZE THE FINANCE DIRECTOR
12	TO APPROVE BUDGET ADJUSTMENTS UP TO AND INCLUDING FIVE THOUSAND
13	DOLLARS (\$5,000); THE CITY MANAGER TO APPROVE BUDGET ADJUSTMENTS
14	FROM FIVE THOUSAND DOLLARS AND ONE CENT (\$5,000.01) UP TO AND
15	INCLUDING FIFTY THOUSAND DOLLARS (\$50,000); AND THE GOVERNING BODY
16	TO APPROVE BUDGET ADJUSTMENTS OVER FIFTY THOUSAND DOLLARS
17	(\$50,000).

19	BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF SANTA FE:
20	Section 1. Article 11-4 SFCC 1987 (being Code 1953, Sec. 2-66, as amended) is
21	amended to read:
22	11-4 BUDGET ADJUSTMENTS.
23	When <u>budget</u> adjustments are needed during the fiscal year, the following procedures
24	shall apply:
25	A. The finance director has the authority to approve budget increases or decreases in

1	revenue or transfers-in or in expenditures, expenses or transfers-out, that reflect increases or
2	decreases in the budget up to and including five thousand dollars (\$5,000).
3	<u>B.</u> The city manager has the authority to approve budget increases or decreases in
4	revenue or transfers-in or in expenditures, expenses or transfers-out, that reflect increases or
5	decreases [from] in the budget [that are thirty thousand dollars (\$30,000) and under] from five
6	thousand dollars and one cent (\$5,000.01) up to and including fifty thousand dollars (\$50,000).
7	[B]C. The governing body shall approve <u>budget</u> increases or decreases in revenue or
8	transfers-in or in expenditures, expenses or transfers-out, that reflect increases or decreases [from]
9	in the budget that are over [thirty] fifty thousand dollars (\$[30,000] 50,000).
0	$[\in]\underline{D}$. Budget adjustments approved by the city manager and the governing body shall
l 1	be included by fund in a quarterly budget resolution approved by the governing body.
12	$[\underline{\mathcal{P}}]\underline{\mathrm{E}}$. Budget adjustment requests will conform to the rules and regulations adopted by
13	the local government division of the department of finance and administration.
14	[E]F. For budgets associated with grants and grant agreements, the following shall
15	apply:
16	(1) The city manager may approve grant applications, awards, grant match
17	requirements, and agreements [under thirty thousand dollars (\$30,000)] from five
18	thousand dollars and one cent (\$5,000.01) up to and including fifty thousand dollars
19	<u>(\$50,000)</u> .
20	. (2) The city manager may approve budget revenue and related
21	expenditure/expense increases (including budget adjustments or decreases, as applicable)
22	for grants provided that all of the following conditions are met:
23	(a) The governing body has already approved the grant application
24	including the recommended match (if applicable); and
25	(b) The final grant award does not significantly differ from the grant

1	application in the amount, match, requirements, or other requirements on the part
2	of the city; and
3	(3) Any city department receiving a grant shall submit a copy of the final
4	award agreement and documentation for the grant to the finance department for financial
5	tracking, reporting and auditing purposes.
