9	BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF SANTA FE:
10	Section 1. Section 24-2.6 SFCC 1987 (being Ord. #2006-14, §26, as amended) is
11	amended to read:
12	24-2.6 Restricted Traffic.
13	A. Trucks, truck trailers and other large vehicles with a gross vehicle weight of five (5)
14	tons or more are prohibited from traveling on the following streets except as set forth in paragraphs B.
15	and C. below:
16	(1) Agua Fria Street, between Siler Road and Guadalupe Street except those
17	vehicles making pickups or deliveries to addresses on adjacent dead end streets;
18	(2) Alamo Drive;
19	(3) Apache Street;
20	(4) Armenta Street;
21	(5) Arroyo Chamiso, Botulph and beginning at the eastern boundary of Zia
22	Road;
23	(6) Calle Angelina;
24	(7) Calle Atajo;
25	(8) Calle La Resolana;

2	B. Trucks, truck trailers and other large vehicles with a gross vehicle weight of five (5)
3	tons are not prohibited provided the following are met:
4	(1) The vehicle is making pick-up and deliveries or providing services to
5	addresses on the specific streets or to addresses on adjacent streets served only by that
6	specific street(s); or
7	(2) The vehicle is traveling to or from such addresses for the purposes of
8	locating permanently or temporarily at such addresses provided they are in compliance with
9	any other applicable city code.
10	C. Authorized emergency vehicles; any government or utility maintenance, service and
11	transportation vehicles; and school buses, with a gross vehicle weight of five (5) tons or more, are
12	permitted to travel on the streets specified above.
